1. WHAT IS THE STUDENT-FACULTY COMMITTEE TO STOP THE WAR IN VIET NAM?

It is a committee of faculty and students joined together to protect the United States' continued involvement in Viet Nam.

2. WHAT ^{ARE} THE DATE, LOCATION, AND TIME OF THE MEETING?

The meeting will be held from 7:30 p.m. on Friday evening, April 23rd, until 7:30 a.m. the following morning. It will be held in the Student Union Building on the campus. Similar all-night meetings have been held at two universities in the State of New York; and one in Michigan.

3. DOES THE UNIVERSITY HAVE A POLICY ON THE USE OF ITS FACILITIES BY FACULTY AND STUDENT GROUPS?

The University has had a long-standing policy of permitting the use of its facilities by members of the faculty and recognized student groups. The University takes no position "pro or con" on the purpose of the meeting. Thus, the same policy would apply to groups taking an opposite position on the Viet Nam question.

4. WILL THE UNIVERSITY INCUR EXTRA EXPENSES BECAUSE OF THE MEETING?

No. The/Committee will pay all costs involved in keeping the Student Union open beyond its normal closing hour, just as other groups have done in the past when using the building for all-night activities - i.e., Eugene High Schools when using the building for all-night graduation parties.

5. IS THE MEETING PUBLIC OR PRIVATE?

The faculty-student committee has invited all students and the public to attend.

6. WHO WILL SPEAK?

A number of speakers have been invited. The four principal speakers are: Wayne L. Morse, United States Senator from Oregon; Robert Scheer, journalist, recently returned from Saigon; Stanley Sheinbaum, economist, Center for the Study of Democratic Institutions and David McReynolds, War-Resister League. Faculty members, students and townspeople will speak at a 12 midnight and 7:00 a.m. rallies.

7. WHAT REGULATIONS GOVERN STUDENTS LIVING IN UNIVERSITY OR UNIVERSITY-RELATED HOUSING WHO WISH TO ATTEND THE MEETING?

The Faculty-Student committee has invited all students to attend. The University never has had closing hours for men living in University housing. For women living in University or University-related housing, the normal closing-hour regulations relating to university-recognized functions will apply. This means that a girl may sign out to attend the

function and must return twenty minutes after its completion.

Women who leave the function ~~after closing hours~~ before the end are expected to return to their living organizations.

8. MAY GIRLS WHO HAVE LEGALLY SIGNED OUT FOR ALL NIGHT RETURN TO THEIR LIVING ORGANIZATIONS BETWEEN 1:00 A.M. and 7:30 A.M. SATURDAY MORNING?

Yes. Living organizations will have someone available to let these girls in during the hours following 1:00 a.m.

9. DOES THE STUDENT CONDUCT CODE COVER SITUATIONS WHERE GIRLS WHO SIGN OUT TO ATTEND THE MEETING BEYOND THE 1: A.M. CLOSING HOURS ACTUALLY GO ELSEWHERE?

It does. Such students will be guilty of violating provisions of the code relative to providing the University with false information, and failing to observe closing hours.
