STATEMENT OF SIGNIFICANCE

Architectural: The Bags Residence, constructed in 1890, was designed in the Dutch Colonial Revival Style. The style, an adaptation of the Colonial Revival Style, is distinguished mainly by its gambrel roof form. Other characteristics include dormer windows, shingle siding, and classically inspired porch posts. The Bags Residence is intact and a good example of its type.

<u>Historical:</u> The property is associated with the following Portland families: W.J. Jacobson, Theodore and Ella Brandes, Kate Supple, A.J. Guist, Thomas and Katherine Cobb, Ralph and Jean T. Shadduck, and David J. and Mary M. Lanahan.

PROPERTY OWNERSHIP HISTORY

- A.N. King deeded lot 15 to W.J. Jacobsen in 1891. Jacobsen deeded the property to Theodore Brandes on March 7, 1901. Theodore and Ella Brandes sold the west 66 and two-third feet of lot 15 to Kate Supple on August 14, 1922.
- 1922-1931 Kate Supple sold the property to Cascade Utilities Company on June 24, 1930. Cascade Utilities deeded the property to A.J. Guist on June 24, 1930. The following year, Guist deeded the property to Thomas Cobb.
- Thomas and Katherine Cobb, husband and wife, deeded the property to Ralph Shadduck on March 29, 1932. Shadduck deeded the property three months later to Jean T. and Ralph Shadduck. Jean T. and Ralph Shadduck sold the property to David J. Lanahan in 1933.
- 1933-1955 David and Mary M Lanahan deeded the property to James Douglas in 1955.

W.J. Jacobsen: No biographical information is currently known.

Theodore and Ella Brandes: According to the 1915 Portland city directory, resided at 743 1/2 Northrup. In that year Theodore is listed as a partner with J.W. Barnes in Barnes and Brandes restaurant located at 107 Sixth Street. In the 1901-1902 Portland city directory, Theodore J. Brandes is listed as the proprietor of a bakery at 390 Morrison and resided at 422 1/2 Morrison.

Kate Supple: No biographical information is currently known.

A.J. Guist: No biographical information is currently known.

Thomas and Katherine Cobb: No biographical information is currently known.

Ralph and Jean T. Shadduck: No biographical information is currently known.

<u>David J. Lanahan</u> (1886-1964), a candy maker, operated the Danby's Candy Store for fifty years. A native of Laurel, Maryland, Lanahan was survived by his two sons, John David Lanahan, and William Ed Lanahan.




