

Extracts from

"Articles of a Treaty made and concluded at Port Orford on the Pacific Ocean and in the Territory of Oregon this 20. day of September A.D. 1837, Anson Dart Superintendent of Indian Affairs, Henry H. Spalding Indian Agent and J. S. Pariseh Sub Indian Agent on the part of the United States and the undersigned Chiefs and head men of the To-to-tan, You-gue-chae, & Dua-tow-wah Bands of Indians of the other part."

Article first "The To-to-tans, You-gue-chae, and Dua-tow-wah Bands of Indians do hereby cede and relinquish to the United States all their right title interest and claim to lands lying within the Territory of Oregon and bounded as follows, to wit: Beginning at the mouth of the To-to-tan or Rogue River, running thence northwardly along the Pacific Coast sixty five miles to the mouth of the Duatowwah or Coguille river; thence up said river to the summit of the Coast Range of Mountains, thence southwardly along the summit of the said Coast Range of Mountains to the aforesaid To-to-tan or Rogue River, thence down said river to the place of beginning."

Article 2^d "It is agreed that the said bands of Indians shall have free and unmolested possession of the ground occupied by their houses, and upon which they now reside, during the ten years in which they receive their annuities and that they shall also be free to fish as they have heretofore done, and it is further agreed, that with the consent of the President, said privileges shall be extended beyond the expiration of the aforesaid ten years."

Article third "In consideration of the cession aforesaid the United States do hereby agree to pay to the said bands of Indians yearly and every year for ten years from

the date of these presents, the sum of twentyfive hundred Dollars in the following articles: to wit:

Seventyfive woollen coats, Seventyfive pairs of woollen Pantaloon, Seventyfive vests, One hundred shirts, Seventy five pair shoes, fifty hats or caps, thirty plaid linsey drapes (ready made) forty calico drapes (ready made) One hundred Blankets, two hundred pounds of tobacco, ten barrels hard bread, two hundred pounds of soap, fifty knives, twenty kettles, twenty pint cups, ten chopping axes, said articles to be delivered at Port Orford and the first of said annuities to be paid in the month of June next."

Extracts from

"Articles of a treaty made and concluded at Port Orford on the Pacific Ocean and in the Territory of Oregon" to wit the "Chiefs and Headmen of the Na-sio-chah Band of Indians."

Article 1st. "The Na-sio-chah band of Indians do hereby cede and relinquish to the United States all their right title interest and claim to lands lying or supposed to lie within the Territory of Oregon and bounded as follows to wit: Beginning at the mouth of the Tototaw or Rogue River, running thence southerly along the Pacific Coast, twenty miles, thence East in a direct line to the summit of the Coast range of mountains, to the said Tototaw or Rogue River, thence down said river to the place of beginning."

Article 2nd. same as Article 2. already quoted.

Article 3. "In consideration of the cession and relinquishment aforesaid, the United States hereby agree to pay to the said band of Indians, yearly and every year for ten years from the date of these presents the sum of

three hundred and fifty dollars in the following articles -
to wit: Twenty Blankets, ten woollen coats, ten pairs of
woollen pantaloons, twenty shirts, ten plain linen
dresses, fifty yards of domestic cotton, ten hats or
caps, ten pairs shoes, twenty pounds of tobacco, fifty
pounds of soap, two barrels hard bread and five
kettles, said articles to be delivered at Port Orford
and the first of said annuities to be paid in
the month of June next."
