The indication given in your letter that Mrs. Daughton had transmitted to you on 25 June 1949 a copy of the 26 June note to Mr. Sharett has assisted in clearing up a misunderstanding, due to a lacuna in the archives of the Truce Supervision Organization in Jerusalem. Apart from the 25 June cable transmitting to Tel Aviv and Damascus the text of the notes to be delivered to the Israel Minister for Foreign Affairs, and the Syrian Minister for Foreign Affairs, respectively, there was another communication addressed to Dr. Mohn only and instructing him to add to the note the passage which was quoted in part by Mr. Tekoa in the conversation on 15 October.
