BENNIKE REPORT "AS MEMBER SECURITY COUNCIL RECALLING IT WAS
DECIDED OCTOBER 19 THAT BENNIKE BE INVITED REPORT IN PERSON ON
ITEM BEING CONSIDERED BY COUNCIL .

"BEFORE PRESENTING BENNIKE ^IMAY/EXPRESS SPECIAL CONCERN AS SECRETARY
GENERAL REGARDING OUTBREAKS VIOLENCE RECENT INCIDENTS WHICH OCCURED
IN PALESTINE CREATING NEW TENSIONS IN MIDEAST. THESE INCIDENTS CONSTITUTE
SERIOUS VIOLATIONS ARMISTICES CONCLUDED 1949.

"CONSIDER IT DUTY RECALL TO PARTIES AS BEEN STATED IN DIFFERENT
~~SECRETAR~~ SECURITY COUNCIL RESOLUTIONS ARMISTICES SIGNED PENDING
FINAL PEACE SETTLEMENT PURSUANT CHARTERS ARTICLE 40 AND INCLUDE
FIRM PLEDGES AGAINST ACTS HOSTILITY BETWEEN PARTIES. THEY ALSO PROVIDE
FOR ARMISTICE SUPERVISION BY PARTIES THEMSELVES AND BY MAC'S UNDER
CHAIRMANSHIP CHIEF STAFF.

"WISH ALSO EXPRESS FIRM HOPE PARTIES GIVING FULL CONSIDERATION THEIR
OBLIGATIONS UNDER ARMISTICES TERMS AND REFRAIN ANY ACTION CONTRARY THOSE
ACCEMMENTS WHICH PREJUDICING ATTAINMENT PERMANENT PEACE IN PALESTINE
WHICH ULTIMATE UNITED NATIONS AIM IN MIDEAST.

"IN CONCLUSION MAY I MAKE STRONG APPEAL TO PARTIES CONCERNED REFRAIN FROM
SPREADING HUMORS PROVOCATIVE ACTS WHICH CONTRIBUTING TO WIDENING AREAS
TENSIONS ESPECIALLY AVOIDING ANY PREMATURE ACTIONS WHICH JEOPARDIZING
COUNCIL'S PRESENT ENDEAVOURS" . END.
