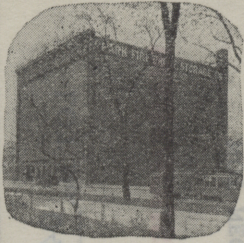

upon the following terms and conditions,

All of said goods and chattels are received by the undersigned and held on storage, upon the following terms and conditions; which are hereby assented to by the holder hereof by acceptance of this receipt:

The OWNER assumes ALL RISKS, and no Liability of any kind attaches to the Company for any loss or damage to said goods caused by moths, fire, rust or deterioration, Acts of God, or other causes beyond its control.

The responsibility of this Company for stored goods under the terms of this agreement only attaches in the case of fragile articles when such articles are packed by its employees and unpacked by them at the time of delivery.

The owner declares that the value of any article, piece, package or receptacle, including the contents thereof, packed, transported, received, handled or stored in this lot, does not exceed the sum of FIFTY DOLLARS, upon which valuation the existing rates shown below have been based, and the owner, in consideration of said rates charged, hereby agrees that the liability of the company, for any cause which would make it liable in case of any loss or damage while said goods are in its possession, shall in no event exceed the sum so above declared, unless the owner declares a greater value in writing, and agrees to pay an additional monthly charge of Twenty-five Cents for each \$100.00 or fraction thereof in excess of the \$50.00 already declared, in which case the said liability of the company, for any cause which would make it liable, in case of loss or damage, shall not exceed the greater value so declared.

The notice of any change of address shall be given in writing, and acknowledged by the company, and no notice of such change shall be valid or binding against the company if given in any other manner.

The goods deposited will be delivered to the above-named owner, or to any other specified person on his or her behalf on presentation of written authority from said owner, provided all storage and other charges are paid.

No transfer of this receipt will be recognized unless all charges are paid, and transfer is entered on the books of the company.

No person is authorized to make any other agreement or condition on behalf of the company.

Persons placing goods in storage shall make a reasonable allowance for ordinary wear and tear in handling, and any claims in reference to such handling, must be made to the undersigned in writing within five (5) days from the date of the delivery of the goods.

That said goods and chattels are received and accepted by the undersigned upon the express understanding that said holder is lawfully possessed of the same and has lawful authority to store the same; and if the undersigned shall be made a party of any litigation by reason of having said goods and chattels, or any part thereof in storage or otherwise, then said holder shall pay any and all costs, expenses and attorney's fees which the undersigned may become liable for or be compelled to pay in connection with any such litigation, and, in addition thereto, a reasonable compensation for the time of the undersigned in connection with such litigation; and the undersigned is hereby expressly given a lien on any and all of said goods and chattels for any and all such costs, charges and expenses, and the same shall be considered as so much additional storage charges.

All the above terms and conditions shall apply to any goods hereinafter stored for this account.

Failure to return this receipt within ten (10) days for correction will be conclusive that the receipt is correct and delivery will be made only in accordance herewith.

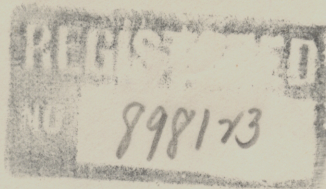

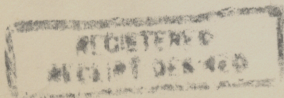
