A BRIEF STATEMENT OF THE PRINCIPAL FEATURES OF LAW AFFECTING THE COLLECTION AND PAYMENT OF TAXES

TO WHOM PAYABLE—All taxes are payable to Fred G. Stickels, Sheriff and Tax Collector, Eugene, Oregon.

WHEN PAYABLE—The first half of all taxes legally levied and charged shall be paid on or before April 5th, following, and the second half on or before October 5th, following.

INTEREST CHARGED—Interest shall be charged and collected on any tax or half of a tax, not so paid, at the rate of one per cent per month or fraction of a month until paid.

WHEN DELINQUENT—PENALTY—All taxes remaining unpaid on October 5th next following, shall become delinquent, and on November 5th next following, a penalty of 5 per cent shall be charged and collected thereon, in addition to the interest provided herein.

In order to escape penalty, taxes must be paid before November 5th.

CERTIFICATES OF DELINQUENCY—Any day after the expiration of six months after the taxes charged against real property are delinquent, the sheriff shall have the right, and it shall be his duty, upon demand and payment of the taxes, penalty and interest, to make out and issue a certificate or certificates of delinquency against such property to any individual making application therefor.

FORECLOSURE OF CERTIFICATE—Any time after the expiration of three years from the first date of delinquency of any tax included in a certificate of delinquency the holder of such certificate may apply to the circuit court of the county in which such property is situated for a decree foreclosing the lien against the property mentioned in such certificate.

Receipts are conditioned on prompt payment of all checks given the tax collector therefor.
