I am enclosing a check to you for two hundred dollars for the work and time that you spent on this problem. Thank you very much.

My knee, plus my leg, has been a bad business. However, while I have been laid up with my other leg, my right knee has been steadily improving. It is in much better shape than it has been in any time since the accident ten months ago, and my left leg, while it has laid me up this past month, and I still have to have my leg bandaged when I am off the bed, it is quite different from a knee injuty, and the doctor says it is bound to get well. The knee is quite a different proposition. However, it is doing very well and I am going to try my best to see that nothing happens to it. The doctor says in three or six months, if nothing happens to it, I can get around on a level without a cane - no steps either up or down permitted even then.

Yesterday and today I went for a short drive. My knee is astonishingly sensitive to the joggle of the automobile - even on the nice fairly smooth city pavements, and so I have it bandaged before starting on the drive.
