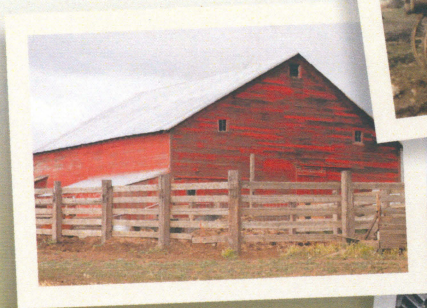

2015 Sesquicentennial Farm & Ranch Honorees

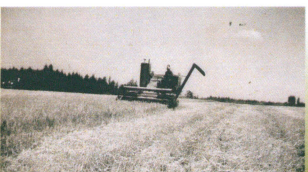
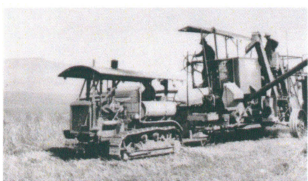
Mid Valley Farm/Flint– Founded in Washington County in 1865 by Benjamin Talbot Flint. Applicant is Harlan & Beverly Flint.

Oregon Century Farm & Ranch Program And Management Committee

The program began in 1958, on the eve of the Statehood Centennial Celebration, to honor farm and ranch families with century-long connections to the land. The program recognizes Oregon's rich agricultural heritage and now has registered 1,175 properties (including this year's honorees) during the past 57 years. In 2008, the Sesquicentennial award was introduced to honor families who have sustained their family farms and ranches for 150 years.
