It suddenly occurred to me tonight that you had sent me a telegram and that I did not answer it. However, I did connect up with Mr Onthank and read the telegram to him, only to find that he also had received one from you. I told Mr Onthank that I would also give \$100 toward the lantern.

You remember that I asked you whether I should speak to the Chancellor about the lantern when he came to the Museum and you thought it would be a desirable thing to do. After Dr Hunter and I had been through the Museum, we went to Mr Harada's office. Mr Harada showed Dr Hunter the illustrations which he wished projected through the lantern. The Chancellor was much interested.

As the situation now stands you will give \$100 toward the lantern, I will give \$100, and the University has found that it can buy a lantern for \$550, which is I understand \$65 less than the quoted price. That leaves the University \$ 350 to raise. In a few days they will know whether or not they have the \$ 350.
