BARBARA LEE BREWTON, an 18-year-old Portland coed is a standout in both her class and classes at Oregon State.

Barbara is not only president currently of the 1715-student freshman class but is also the only freshman woman enrolled in the school of engineering this year. In four of her classes, she's the only girl.

Miss Brewton, who wants to be a chemist after graduation, is enrolled in chemical engineering. Fall term, she made a 3.06 grade average. Her father is a civil engineering graduate from Georgia Tech and a Portland engineering contractor.

She was elected vice president of her class at the opening of school and stepped up to the top spot temporarily this term when the president resigned.

Grades

FIRST PLACE in living group grade standings last term went to Kappa Alpha Theta sorority. Azalea house took grade honors in the women's clubs with a 2.69 while Hawthorne manor had a 2.63 to lead the men's clubs. Sigma Phi Epsilon had top grades of fraternities with a 2.66. The student body grade average was 2.50. This was a slight drop below the Fall, 1953 grades of 2.51. The all-men's average for Fall term was 2.44, with the all-women's average at 2.66. The first five living group placings are as follows: Sororities: Kappa Alpha Theta, 2.91; Kappa Kappa Gamma, 2.84; Delta Delta Delta and Delta Gamma, both 2.79; Pi Beta Phi, 2.77; Alpha Chi Omega and Delta Zeta, both 2.76; Gamma Phi Beta, 2.75.

clubs: Hawthorne Manor, 2.63; Davenport house, 2.52; Campus club, 2.51; Poling hall, 2.50; Beaver lodge, 2.48.

Grid Seniors: Seniors on last Fall's OSC football team were presented with solid gold rings at the annual senior ring banquet at the Benton hotel in late January. Receiving rings were Jim Withrow, Wes Ediger, Laird Brattain, Jack Peterson, Jim Roberts, Bill Johnson, Ron Aschbacher, John Hall, Lew Williams, and Claret Taylor.

Killed: Vernon Eugene Duiker, 28, was killed January 27 when a car in which he was riding plunged off the Philomath road and struck a tree a half mile west of Corvallis. Duiker was a research fellow in zoology and had been at OSC since 1952. His home was in Volga, South Dakota.

Pop's Day: Dads Weekend was held on the OSC campus February 11, 12, 13. This was one of the first years that a basketball game wasn't the feature attraction of campus events. Instead the dads listened to the Intersorority sing, attended a wrestling match, a speech department play, a swimming meet, and talked to their children.

Comedy: Sabrina Fair is the second speech department play of Winter term and was held March 3, 4, 5. The play, a romantic three act comedy, featured a cast of seven men and seven women.

Back Again: "Bean Spearing" is now coming back at an active tradition on the OSC campus. The Junior Interfraternity Council announced plans for the systematic exchange of dinner guests. Previously the tradition was spasmodic with Greek men attending other fraternities for lunch whenever anyone thought of making an exchange. At first only freshmen will take part in the "bean spearing" with the JIFC doing the scheduling.

Drafted: Bill Toole, the senior basketball guard who hasn't played football since high school at Klamath Falls, was recently drafted by the New York Giants professional grid team. The Giants apparently got the word about Toole's speed and foot-

ball potential from the former Beaver backfield coach, Ward Cuff, who used to play pro ball for the Giants. Toole indicated however that he didn't think he would even try out for the Giants. He's an engineering student.

A Change: The Memorial Union lounge rug has been replaced after 26 years at the cost of \$5233. Ed Allworth, M.U. manager, said that the funds came from government war bonds purchased ten years ago especially to go toward getting a new rug. Eight men were required to life each quarter section of the rug which measured 38 by 76 feet. Padding under the rug is expected to add 10 years to its life so that the rug will last from 25 to 35 years. The new carpet, an Alexander Smith Saxony, is an exact copy of the former rug which was designed to fit the lounge in color and pattern by an interior decorator.

Parking: With parking always a problem on college campuses the OSC physical plant is constructing additional parking space on the west side of the armory. Part of the row of locust trees is being removed and curbing is being constructed around the remaining trees to form islands.

Map Study: A collection of captured military maps from World War II has been deposited in the college library. The OSC library is one of two libraries in the Pacific Northwest to be selected because of geographical location and adequate facilities to insure good usage. The maps are under the jurisdiction of the defense department. All the maps are printed in German, Japanese, Russian, or Chinese and are being translated and filed.

Mortar Board: OSC men got the one chance of the year to sit back and let the coeds do the worrying about dates. Mortar Board was held February 5 in the M.U. ballroom with the theme of "Graecia". The ballroom was decorated like a Grecian temple with white columns, ivy, and flowers. Profit from the dance is used for the annual Mortar Board scholarship, which is given to an outstanding junior woman each Spring.

This year the Mortar Board women picked a King from the male students. He turned out to be Johnnie Rice, '55, and he was picked because he most resembled Apollo, Greek god of manliness and beauty and also because he had nicely shaped legs. 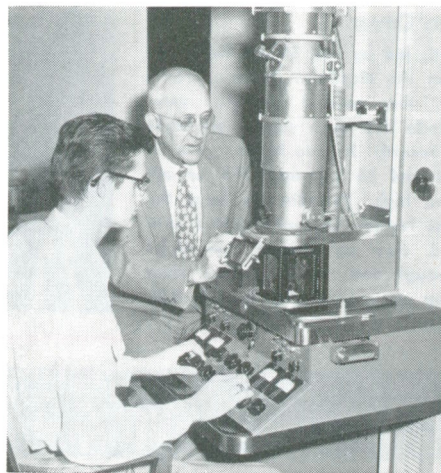

THE HUMAN eye has its limits. We might say it sees things as they are. But with the aid of magnifying devices, man is able to explore the not-so-obvious. To assist in looking beyond in science, Oregon State College purchased an electron microscope in 1951. Funds came from the budgets of the school of science and the agricultural experiment station. Price: \$18,000.

An electron microscope is no ordinary instrument. It is capable of magnifying up to 100,000 times. A usually-used microscope has a 3000 power limit. And the electron microscope uses a focused beam of electrons.

This microscope is extremely valuable to Oregon State for the work the college can do for orchardists, truck farmers, health scientists, dairymen, cattlemen, metallurgists, and others. The scientist who has a research project which fits can use the microscope wisely.

Dr. K. S. Pilcher, head of bacteriology, says his department uses the electron microscope primarily for visualization of virus particles, mainly of influenza and mumps.

OSC bacteriologists are studying chemical interference with virus growth using specific organic compounds that bear some structural resemblance to normal metabolites. Metabolites are compounds utilized in normal biochemical processes associated with living tissues.

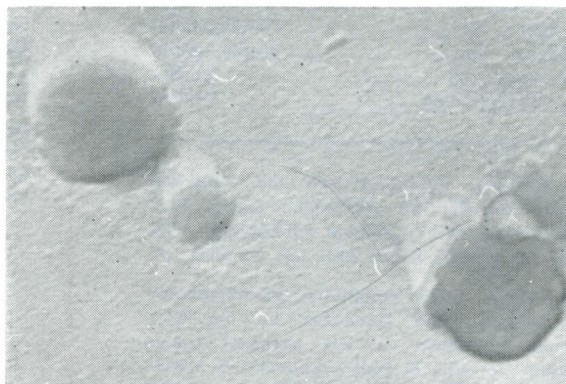
Dr. S. H. Wu, research assistant in animal husbandry, is doing scientific research on sperm with the help of the electron microscope. His work has to do with the internal anatomy of sperm types. Sperm examined has been that of sheep, swine, cattle, horses, guinea pigs, rabbits, rams, swallows, cockroaches and frogs.

This original research on spermatozoa has already shown a similarity between the sperm types in the composition of the middle part of the three-pieced sperm.

Dr. Fred McKenzie, head of animal husbandry, reports his department will use the powerful microscope for future studies on animal diet.

Oregon's crime laboratory has made use of the microscope to identify particles on clothing. To gain knowledge of the workings of animal and plant life, some of the other things "looked at" have been tomato and potato viruses and the western-x little cherry virus.

Dr. F. A. Gilfillan, dean of science, said the new microscope has and will be used for research on such things as Brucella, the bacteria that causes undulant fever in human beings, and studies on molecular structure of chemicals.

The four final choices were Tommy Prothro, UCLA backfield coach; Skip Stahley, Idaho head coach; Hampton Poole, recently resigned mentor of the professional L. A. Rams; Herm Meister, line coach at California. Prothro will fit in well at Oregon State. He is hardworking, firm, quiet. His 6-3, 230 pound frame gives a definite air of authority. Like former backfield coach, Ward Cuff, Prothro wears horn-rimmed glasses and can look pretty studious. He's a good bridge player, chess player, doesn't go in too much for golf. The man has good contacts in Southern California which should help. Prothro too, is fairly well independently fixed financially.

Resigning coaches, Kip Taylor, Ward Cuff, and Len Younce haven't announced any plans as yet but more might be known by the time you read this. Rumor has it that Younce will get the head coaching spot at Portland State. Len is also supposed to have a good business offer. Ward is rumored to be interested in a coaching berth in the mid-west and Kip wants to stay out on the West Coast. He's been mentioned as a possibility to head the proposed new Portland sports area.

Professor Paul Knoll of the speech department received loads of publicity recently when his wife signed up for one of his classes in argumentation. It was a natural and almost every big publication in the U.S. picked up the story with the idea that a wife learning how to argue was every unusual. Reception would cover vast areas of Oregon . . . at least most of the high population areas. Cost of setting up stations would be around \$800,000. Legislature is considering it. Educational TV channels have been reserved but pressure is being brought to bear to open channels up to commercial stations. State owned television would be similar in set-up to the KOAC radio station.

Football coach Tommy Prothro has been meeting alumni in various parts of California. He met Corvallis people at a February 22 Chamber of Commerce luncheon. Expect Prothro and staff to really cover state meeting OSC people. Also expect new coach to attract some good junior college players. Prothro thinks that state of Oregon has fair amount of good football material . . . at least boys who can fit into his style of play.

Why Ignore The Obvious?

LET'S FACE IT—higher education in the state of Oregon is at an important threshold.

Swept along on the stream of politics in the present legislature is the powerful movement creating the sixth state-supported institution of higher learning in a state with the population of less than two million. Portland State College is an assured project. The legislature has given the green light. The state board of higher education has okayed Portland State. What else could they do? Their problem now is to keep it within bounds so that it doesn't eat away at the very foundation of the state system and cause the whole system, set up in 1932, to come tumbling down in a disorganized heap.

Obviously, Portland State will have to be reckoned with. As a down-town "street-car" college, there is much that can be said for a center-of-population college. But what of the rest of the state system? Will the spreading out of the educational tax dollar hinder the programs of the rest of the system? Again it is obvious that it will. Oregon State's technical set-up requires vast class room and laboratory space. The creation of a sixth state institution now threatens seriously the hope that OSC will get its vitally-needed classroom and laboratory facilities.

The move in 1932 to consolidate the university and the state college could have been the answer. But, again politics and emotion combined to thwart the common-sense plan. Twenty miles north of Corvallis lies another state-supported institution—again spreading out educational tax money. Inside of 60 miles there are three schools and within 140 miles there are four state schools in the field of higher education.

The only salvation for the state system of higher education and this problem is to make sure that 1) PSC remains a down-

town college and 2) that Portland State does not turn into a professional-field college. As matters now stand the state system and the legislature are in accord on these points. But who knows just what will happen in the next decades. There are powerful groups—the metropolitan press, labor, Portland businessmen for example—who seem over-anxious to build a large college in the City of Roses.

The supporters of Portland State, as do officials of the state system and of OSC, maintain that a degree-granting college in Portland will relieve some of the undergraduate pressures in the future. True. But Oregon State, being in the scientific fields, cannot expect to scramble for funds with all the remaining liberal arts and teaching institutions. President Wilson of the University voiced the opinion that his institution doesn't need classroom buildings. President Strand recently came out and said that OSC definitely needs classroom and laboratory space.

At this very moment, with but slightly over 5,000 students, Oregon State is forced to use makeshift quarters for important research and laboratory work. As indicated by the photos, the zoology department is spread out into the old and ramshackle building that used to be the president's home. We but look at the 1955-57 biennium building program to find that of the 13 proposed projects, OSC asks for two buildings to relieve the congestion in scientific instruction. OSC also asks for the necessary heating tunnel. At the university the officials there ask for funds for a swimming pool, an addition to their already impressive administration building, an armory for army and air corps instruction plus addition and remodeling of the art-architecture building and the remodeling and addition to the music building so that "they can provide adequate and safe storage for band instruments, and music and uniforms, and

class room space."

It is definitely hard for the state system of higher education not to be politically conscious when dealing with legislatures, tax monies, and people. But it makes many persons quite perturbed to see facilities lacking at the present time for important work which would benefit the state and the nation and still have the haggling for appropriations. The state educational system is skating on thin ice—a little more weight and we'll all tumble in. Oregon Staters should realize the cause and effect of this new and disturbing higher educational problem. Perhaps something can be done about it.

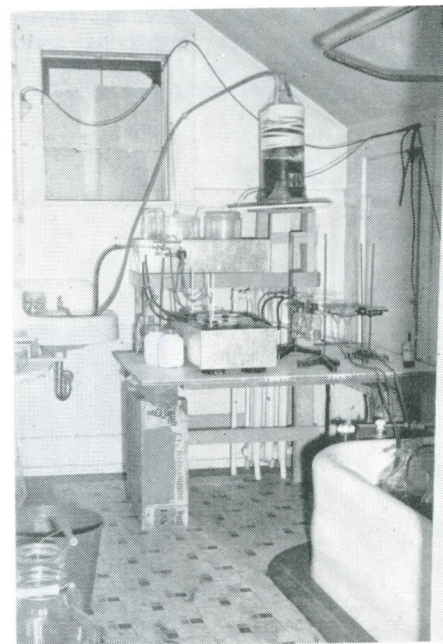
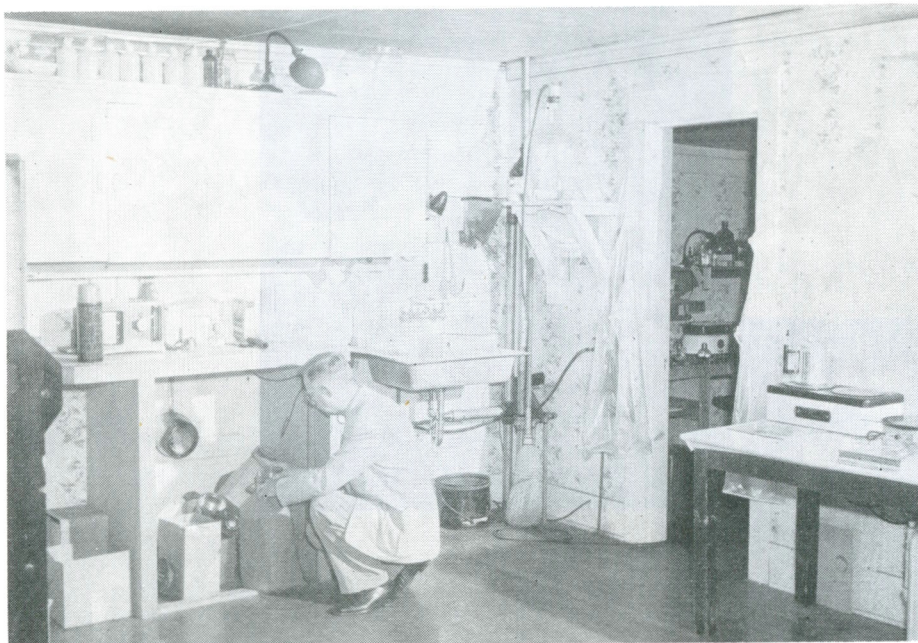
The Barrington Report

MUCH discussion is being heard about the state concerning the report made to the Oregon legislature by Barrington Associates, a New York management consultant firm. It is too early to see the chances for adopting this measure or to predict just what consequences would occur. Needless to say, not too many persons adequately understand the proposed measures.

Briefly for alumni information is the content of the Barrington plan. The Barrington plan is a state pay plan for which the state's 17,500 employees are classified under some 1000 new positions, each in one of 23 pay brackets. Each pay bracket offers a series of five upward pay steps, each representing a pay increase of 6 per cent of the starting salary. Promotions from step to step would come in merit review at least once every two years.

Barrington Associates studied the state's 17,500 jobs on an individual job basis with a questionnaire as to job duties and responsibilities. If such a plan were passed by the legislature many persons in state jobs could be eventually reclassified into a lower

A Winter Habit

Favorite pastime is to pull for Beavers

BASKETBALL is a winter madness at Oregon State!

Nearly 160,000 persons will have crammed their way into the coliseum this season to watch the hoop sport. This is the second straight year OSC has won the northern division basketball title. Since the war Oregon State has dominated the northern division basketball race by winning four titles. And this is the last year that the northern division will operate as such because of the the new Pacific Coast Conference schedule.

For the last four years the western regional NCAA playoffs have been held in the coliseum. This year OSC's fans are hoping to see the home town Beavers fight it out in the national play-offs. The Orange and Black narrowly missed last year by losing the PCC title playoffs to Southern California by three points in the third game of the series.

What makes the Beavers a powerhouse year after year in basketball? Usually the frustrations of each football season are taken out on the hardwood court during the winter months . . . so the Beavers have a rabid, solid rooting section that delights in its hoop victories.

Probably the answer to OSC's strength lies in the all-around strategic brilliance and reputation of head coach Slat Gill. Gill has been handling the Beavers for 27 years. He knows basketball. He knows basketball players. Success always seems to bring more success. The top high school ball players in Oregon and even neighboring states usually find their way to the Corvallis campus. The alumni are proud of OSC's

basketball reputation . . . and they work hard to insure that reputation.

Gill's players are almost assured by the record that if they play at Oregon State they will at least take the northern division crown and have a chance for the PCC crown before they graduate. Since Slat took over as Beaver mentor OSC has participated in seven Coast playoffs (an eighth coming up) and has won three of them. Two of his teams came close to the national title. One won fourth place in the nation, the other fifth.

The 1955 edition of OSC basketball has been compiling an outstanding record in division play. They've swept the four game series with Washington . . . something they've never done before. They won 13 straight in league play.

Yes, basketball at Oregon State is a thrill a minute. It sometimes turns the fans inside out with excitement and emotion. It keeps them on the edge of their seat. Sometimes it's almost too much. But the fans love it and they keep coming back.

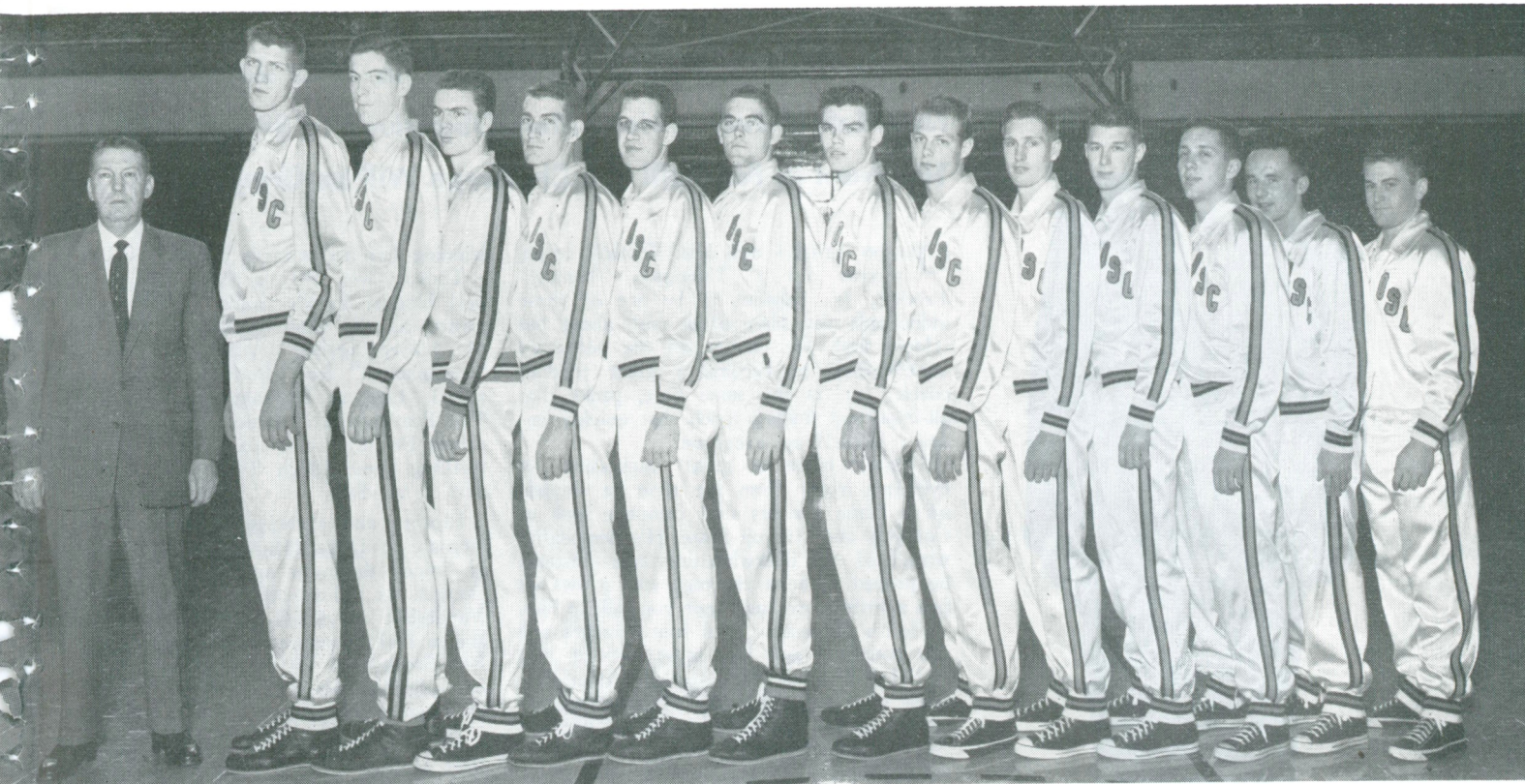


The OSC faculty pulls hard for the Beavers.

Beavers Take 13 Straight and Title

WELL, SLATS GILL and his basketball Beavers have done it again—another northern division championship all wrapped up for presentation to a grateful Oregon State populace. Everyone around Corvallis seemed to sense it was coming, though at times the Beavers gave many anxious moments to spectators who expected them to win by larger margins. Whenever they needed to, these 1955 kids could turn on the steam, and though not as spectacular and poised as the great 1947 outfit, they still had it in the clutch. Certainly their record was one of the best anywhere.

As we went to press, Oregon State had swept 12 victories without a defeat in northern division competition. Since Swede Halbrook returned to the squad, they hadn't lost a game. Next series coming up was at Pullman, against Jack Friel and his always dangerous Washington State Cougars. After that, a two game series with Oregon and another northern division season would again be history.

So many interested fans have asked, "why is this year's team so much better than the 1954 club that also won a northern crown but lost to Southern California in the Pacific Coast conference playoffs?" After all, they reason, the personnel is practically the same as a year ago, with only Ted Romanoff missing and none of the new sophomores playing much. Is the northern division, gen-



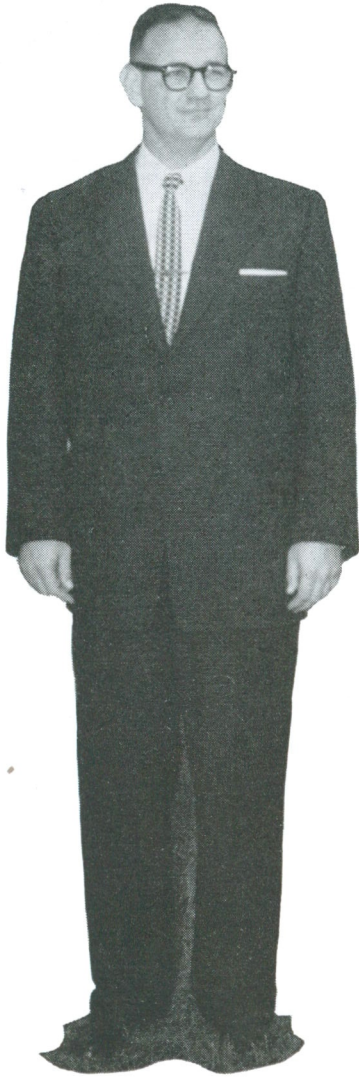

erally speaking, weaker than last year?

Any normal college athlete is sure to improve with each year of experience. Thus one would expect all of the boys who played last season to be vastly improved, simply if because only for the additional year. Halbrook most assuredly is better—much better—than ever before. Tony Vlastelica, as an all-around basketball player, improved by leaps and bounds, even though his shooting in recent games was a bit below average. He still remained the type of player who could break up a ball game faster than anyone else when red-hot. Ron Robins, always spectacular in the past, proved more consistent than in past seasons. Bill Toole had

his moments—especially in that one Washington game at Seattle which he took over and won almost single-handedly. And where would a coach find better substitutes than Reggie Halligan, Tex Whiteman, Ron Fundingsland, Johnny Jarboe and Larry Paulus? They all had their moments, as did regular Jay Dean, the rebounding forward. It was a team effort, rather than an individual one, that brought OSC its ninth northern division title and an eighth crown for Slats Gill. The Beavers have done right well in basketball since the close of World War II. Stop to consider that in that space of time, the Beavers have swept four N.D. titles as compared to four for Washington and one for Washington State. The University of Oregon, our traditional rival, hasn't won a championship since wartime season of 1945—when the men were away defending their country. The Cougars won top prize in 1950, when Gene Conley and Ted Tappe were prize sophomores. Washington, of course, had some great teams and has shared the post-war spotlight with Oregon State.

As this was written, the Beavers had taken 12 in a row without a defeat, which in itself constitutes a new Oregon State record in conference play. All the odds were against their sweeping all 16 games—it never before had been done in conference

Tommy Prothro Played against OSC in 1942 Rose Bowl and Now Takes Over as Head Man. Objective? To Bring Beavers To The Front In Football! The Challenge Will Be Great.

OREGON STATE's new head football coach, 34-year old J. Thompson "Tommy" Prothro, Jr., happens to be one of those individuals you have often read about but seldom find. He carries all the necessary qualifications to become a great football coach; yet, at the same time, packs that all-important human touch that quickly endears himself to everyone.

Tommy made a great impression on everyone, right from the time he stepped off a plane for his first complete look at Corvallis and Oregon State. His personality wasn't of the overwhelming type—instead, he proved to be a charmer who grows on you a little more each time you talk to him.

He's a big man—at 6 foot 3 inches and 230 pounds—and like most men of that size, has a wonderful sense of humor. Because of a sharp wit and distinguished appearance, he's sure to be one of Oregon State's best good-will ambassadors. It's no secret that he was Red Sanders' agent No. 1 along those lines while at UCLA.

Even before he was named head football coach, Tommy made no special promises. He said he had high hopes for Oregon State football, but that he expected it to come gradually—not all at once. In selecting his own assistants, he sought young aspiring men who like himself were well-versed in the single wing style of football.

Few college coaches have such an outstanding background in sports. At Central high school in Memphis, Tenn., in the years 1934-1935-1936, he competed in football, basketball, baseball and track. He was in all of those sports at Riverside Military Academy in 1936-1937-1938. At Duke university, Prothro was blocking quarterback,

winning two top awards during his career.

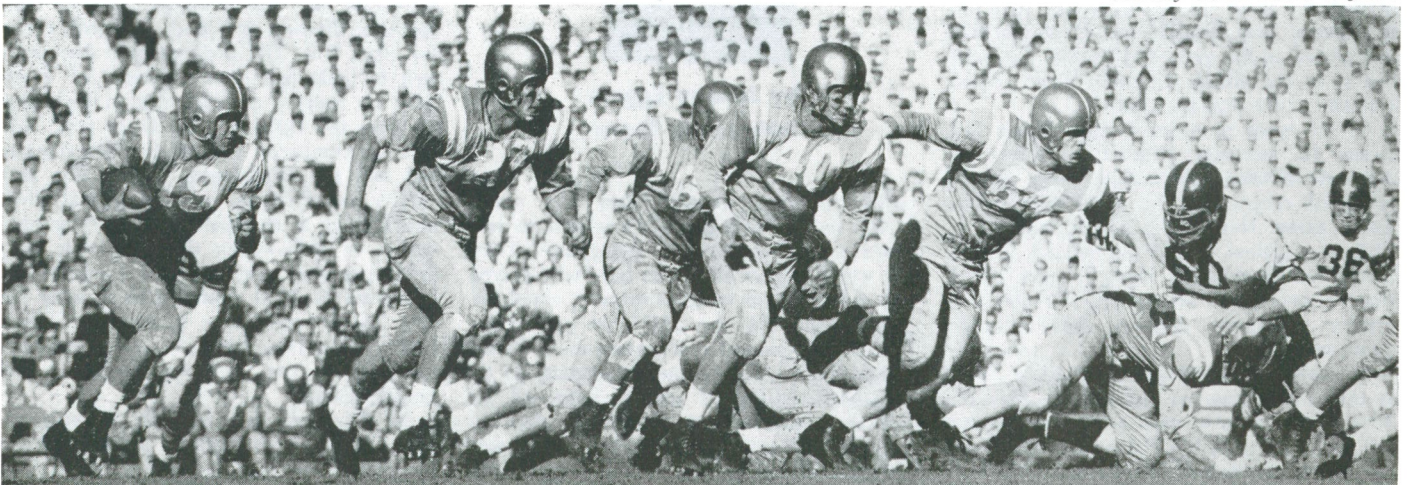
Tommy won the Jacobs award as the best blocker in the South, and the Mills award as the best blocker in the East. He played against Oregon State in the "transplanted" Rose Bowl game of January 1, 1942, at Durham, North Carolina. The Beavers, heavy underdogs to lose, surprised Prothro's club and won, 20-16, in a thrilling game which Tommy still remembers so vividly.

Prothro also participated in baseball and lacrosse at Duke from 1938-1942. In 1942, he joined the navy and in 1945 was discharged as a lieutenant. Tom coached the Vanderbilt university "B" squad in 1946 and in 1947 he became backfield coach under Red Sanders at Vanderbilt. Shortly before entering the service, he was line coach at Western Kentucky.

He went with Red Sanders to UCLA in 1949 as backfield coach and remained there until his appointment at OSC. He generally is credited with developing such top ball-toters as Paul Cameron, Primo Villanueva, Bob Davenport, etc. He is single, but plans to be married to Miss Shirley Seagle of Memphis, Tenn., early next summer.

Tommy is the son of the well-known baseball figure, Thompson "Doc" Prothro, one-time manager of the Philadelphia Phillies and other top clubs. His father formerly played third base for the Portland Beavers of the Pacific Coast league when Tommy was a youngster. He vaguely remembers his days at Vaughn Street ball park. Tommy also is the nephew of General Clifton B. Cates, former commandant of the U. S. Marine Corps.

Allowable Deductions High for Schools

Dear Oregon Stater:

I suppose that there are two extremes amongst those of us who make out our income tax returns. There are the "eager Beavers" who get right at it as soon as the W-2's come in or the necessary information is at hand and not longer after the first of January they have their tax figured out, return made, and either pay up or ask for a refund. On the other end of the log are the majority of us who wait 'till the last minute to do what should have been done three months ago. As you read this the "eager Beavers" are through and the

rest of us are waiting. To both classes of returnees it is a good time to talk about income tax returns and some of the benefits that can accrue if full advantage is taken of "what the law allows".

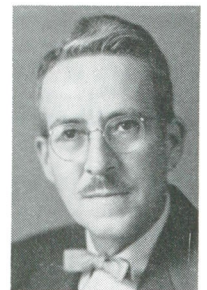
I am indebted, through Dr. Strand, to the Board of Christian Education of the Presbyterian Church for the following information on the working of the new law on internal revenue.

"**Uncle Sam 'ups' allowances on gifts.** Probably you've already noted that the new regulations on income taxes have provided for a substantial increase (up to 30%) as an allowable deduction, especially where some gifts are paid directly to **churches, schools, or hospitals.** This new law, effective for the 1954 tax year, provides that 30% of adjusted gross income may be deducted as contributions if at least 10% is given directly to church, school, or hospital. In other words, the old 20% deduction still stands; but if you want to give 10% more directly to your church, school, or hospital that may be deducted also.

"Still other provisions make it possible to give generously and avoid serious loss to yourself. For instance, if the sale of stock or real estate were to result in a large capital gain (getting more than you paid for it) your government says in effect: 'Give the stock or property to your church,

school, or hospital and let it sell and receive the full benefit of the gift tax-free. You will have no capital gains tax (which is heavy) to pay; and you can deduct the full current value of the gift—within the limitation, of course'.

"The 20%-30% formula works as follows: (20% deductions for gifts as formerly. You may take the additional 10% deduction only if the additional gifts go to church, school, or hospital). Assume that your adjusted gross income is \$10,000. If you gave:

"Bear in mind:—A contribution comes off the top income tax bracket of the individual donor, who files his return detailing his deductions. Your actual cost is what you would keep had you not made the contribution. Thus, the contribution represents actual net cost-plus the share borne by the government in the form of taxes it contributes to the cause.

"This is the way it works: (taking tax rates at random from the complete table). When you make a gift to church, school, or hospital, and take the deduction, the government, by paying the tax per dollar, helps you as follows:

| If your income tax rate is | When you take the gift deduction the government pays per dollar | Net cost to you |
|----------------------------|---|-----------------|
| 22% | \$.22 | \$.78 |
| 30% | .30 | .70 |
| 38% | .38 | .62 |

As the advertisement says "It's too late for Herpicide" as far as 1954 is concerned. However, unless there is a change in the law this year the same benefits, tax-wise, will be in effect for 1955. The above information may serve to indicate to you how much it would cost you to help Oregon State College. The Foundation qualifies under this law and anything that you give to it will help make up the 30% allowable.

In order to visualize the eventual good the Foundation can do for the college, one needs to see it in much the same light as one sees insurance. Take my case for an example. I have had insurance now for 25 years. The fact that I am still here is proof that it has not been needed. However, during the years when my children were younger there was a great need for the protection. I paid out the premiums each month on that insurance well knowing that a great deal of it went to keep the company in business so that someone could eventually collect the benefits upon my death. So it is with the Foundation. We must look at it in the same vein. It has to be kept alive and solvent through a number of years of austerity so that eventually it will fulfill its purpose. That the Foundation can fulfill

that purpose has been demonstrated over and over again in other institutions, both private and state supported, so the only question to be answered is the important one, "Do we want Oregon State College to fulfill its destiny as a land-grant college by going on to greater things, which a healthy Foundation can help produce, or do we want it to stand still (or slip backward) on the basis of state support only?"

The immediate answer to that question is obvious. The implications of the obvious answer are perhaps not as clearly seen. To keep the Foundation solvent, vital, an everpresent entity ready and able to assist in the growth of a greater Oregon State College by the wise use of monies left to it, it will require the aid of all of us through the years to come. If that is what we want to do, and I hope for the good of the college and the state that it is, then we must all pitch in and help. You can do your part by using the attached cut-out to send in a donation, which, if you so desire, will be deductible this time next year at tax return time.

Dixon hasn't much on his freshman team, but the varsity has more than made up for it.

NEW FOOTBALL COACH Tommy Prothro completed his staff by naming two former UCLA players and the line coach at the University of Wyoming.

The ex-UCLA players are Bob Watson and Bob Zelinka, both 25 years old. Watson is the former Medford high school football star who played with the Bruins in 1948, 1948, 1950. He was graduated from UCLA in 1951 and since then has been a mortgage loan officer for a logging concern in Los Angeles. Prothro said of Watson: "I wanted him. 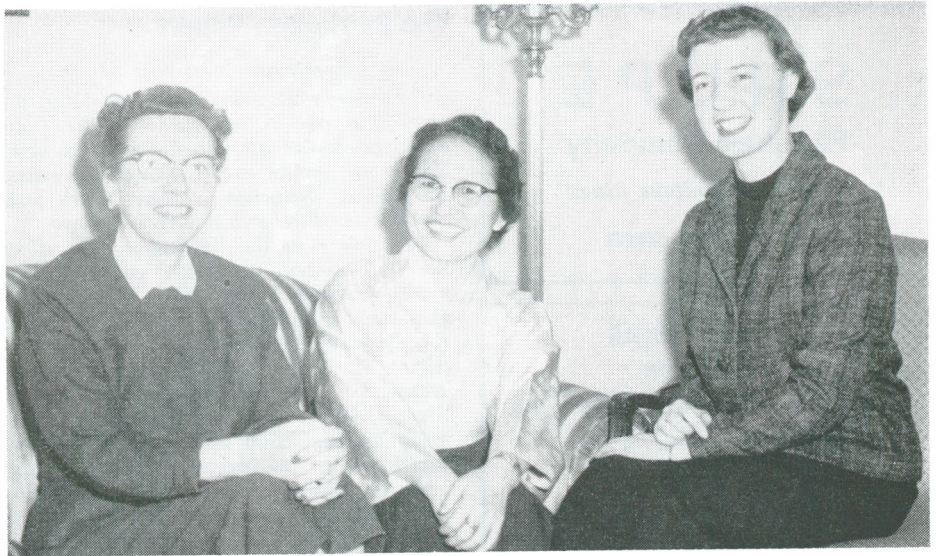

pay division while many others would get an immediate pay boost. Some 14,500 state employees would get adjusted into the new, higher pay groups over the next two years. Barrington Associates claim their plan would eventually save the state money.

Just how does the Barrington plan affect the state system of higher education and more specifically Oregon State College? The plan could establish a director of personnel for the state. This would take the administration of college staff away from the state system of higher education and Oregon State College. Also, and more specifically, much dissatisfaction among OSC's faculty would result. Not necessarily from the pay involved because many faculty positions would receive pay increases, but because a great teaching and research institution such as OSC would be governed by state authority that might not have the interest, the experience and the responsibility which would permit an understanding of the objectives and practices of the teaching and research profession.

The American Association of University Professors at OSC is definitely opposed to the plan. They believe that the State Board of Higher Education, as it has successfully operated for the past 23 years, should rightfully remain in control of all responsibilities having to do with higher education.

Alumni of Oregon State should be familiar with any proposed measure that would change in any way the system of higher education in Oregon. If alumni accept and believe in the method of state control as proposed by the Barrington report that is perfectly all right, but if they disagree, as The Oregon Stater disagrees, then understanding and helping solve this problem is a logical next move.

Some people believe that the Barrington plan will have too much opposition and will not pass in the legislature. The very fact that \$50,000 was spent by the state to get such a plan and that it was proposed at all is an answer as to the intent of state control in the Oregon scene.
