The College

PRESIDENT STRAND termed the week of April 25 to May 2 the "best week of my whole time at OSC." Strand was referring to the week spent on the campus by Dr. Robert J. Oppenheimer, one of the nation's leading physicists, and the annual Biology Colloquium attended by many of the U. S.'s leading scientists. It was at these events that Strand thought the college benefited greatly by the academic stimulation of some of the finest minds in the world. Dr. Oppenheimer was the leading figure in the Condon lecture series held annually on campus and huge crowds gathered in the coliseum to hear the famous scientist speak on the "Constitution of Matter." Oppenheimer visited some of OSC's classes while he was here and guest-lectured in philosophy and science.

Operetta: "The Mikado," famous Gilbert and Sullivan comic operetta, was presented by the Associated Independent Students during Mothers weekend May 12 and 13 in the home economics auditorium. The affair was one of the first operettas put on by students in many years.

Editor: Jim Lattie, '56, from Medford was selected as Barometer editor for the 1955-56 year. Lattie has been Barometer news editor, night editor, and a photographer for the OSC news bureau. He is also president of Sigma Delta Chi, national men's journalism honorary. Bob Scott, '56, of Salem, was announced as business manager for the student newspaper.

Winners: Beta Theta Pi, Sigma Chi, and Sigma Phi Epsilon won the top three places in the 15th annual interfraternity sing in May. The Beta house retired the trophy for the IFC sing after winning the contest three years. Delta Tau Delta fraternity was awarded the Thane trophy for the best freshman class on campus. The award is earned on the basis of leadership, grades, and social activities.

Seventeen OSC students received full-tuition scholarships from the Mothers club Spring term. Each scholarship is now worth \$195 a year, an increase of \$30 per year. The increase was necessary to meet the new tuition rate recently made by the state.

Thieves: During Mothers weekend at OSC thieves robbed four visiting mothers of over \$200. The mothers were staying at the Lambda Chi Alpha fraternity when their purses were rifled.

Southern Flavor: The Sophomore Cotillion, annual Spring formal, had the theme "Southern Accent." Decorations carried out the theme by portraying scenes of old-fashioned southern life. Mint julp programs made of glass and straw were handed to dancers as they entered the coliseum.

Beauty Treatment: OSC's Parker Stadium is due for a face lifting. The slopes of the stadium will be planted with shrubs, trees, and ground cover. Juniper, brooms, rhododendrons, and other plants which can withstand the dry gravelly soil will be used.

Better Spirit: The junior class this year decided on a "Grubby Day" to promote class

spirit. Class members were allowed to wear pedal pushers, Bermuda shorts, sweat shirts, and blouses to classes. The day ended up with car rally and then a class picnic at Avery park.

Speaker: Last convocation of the year was held May 25 in the home economics auditorium when Thurgood Marshall, one of the outstanding Negroes in the U. S., spoke to the students. Marshall, a lawyer, is the chief legal officer of the National Association for the Advancement of Colored People.

Insurance: The ASOSC senate voted to continue selling insurance policies next year. Benefits in the student accident insurance policy have been increased. Up to \$500 will be paid for medical, dental, and surgical expenses resulting from accidents on and off the campus. Policies sell for \$1.50 a term with coverage for 12 months. Approximately \$5,000 was paid to OSC students this past year for medical expenses.

Shocked: Dairymen of Oregon were reported shocked when they learned recently that OSC's dormitories use mellorine, a coined name for a frozen dessert, instead of ice cream. Director of Dormitories Robert Koehler said that the college has been using the frozen dessert in recent years and that also OSC was using margarine for all cooking since 1948. Koehler said it was a matter of economy and that the substitutes were accepted by the students. The dormitory director also pointed out that money saved in this way is used for other foods for the students.

Model U. N. Here: Next year the model United Nations conference will be held on the OSC campus. Oregon State students attending this year's meeting in San Francisco issued an invitation from the college to some 1,200 delegates representing 100 west coast colleges. The model conference was started five years ago to provide college students an opportunity to understand the work and organization of the original U. N. The 13 Oregon Staters attending this year's meeting represented the Dominican Republic and were entertained at a banquet by the Dominican Republic consul-general.

Awarded: Twenty-nine research grants, totaling \$11,200, were awarded to faculty members for the 1954-55 year by the graduate school. Eight new grants were announced also by Dr. H. P. Hansen, dean of the graduate school. The new grant-in-aids for research total about \$1,200.

Science: Science exhibits made by "budding" school-age scientists were displayed May 1 to 6 at OSC in the third annual Northwest Science Exposition. The best 500 entries from various school, county and district shows were brought to the exposition. The show was sponsored by the Oregon Museum of Science and Industry.

Student Drowns: Fred Aldridge, 17, an engineering freshman at OSC from Pendleton, drowned June 6 while swimming with two Delta Tau Delta fraternity brothers at Colorado lake near Corvallis. Aldridge went down in about 30 feet of water. He was pulled out by a life guard in five minutes but two hours of resuscitation efforts were futile.

Gift: A \$100 gift has been received by the Memorial book fund of OSC's Kerr library in memory of Lt. David A. McCoskrie, former OSC student in 1943. Lieutenant McCoskrie was killed in Korea in February 1951. The gift was presented by his parents.

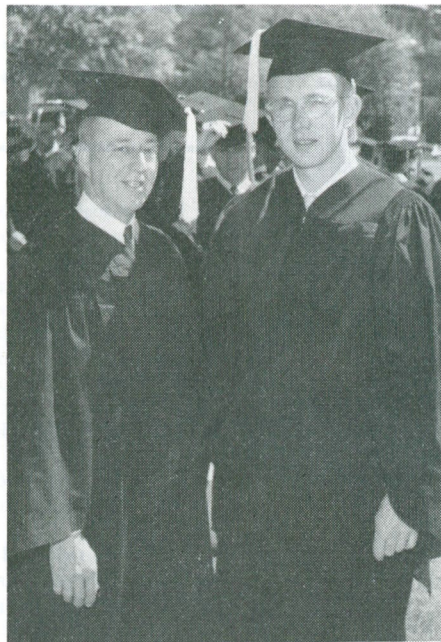
Help Day: OSC's 30 fraternities participated in the third annual "Help Day," May 7. It was sponsored by the Interfraternity coun-

cil. More than 300 fraternity men painted and cleaned up areas around the city's churches and recreational areas and the Children's Farm Home. Sororities fixed lunches and delivered them to the workers.

Moms Elect: Mrs. S. W. McHugh of Corvallis was elected president of the Oregon State Mothers club in May. Mrs. Victor Carlson of Lebanon is retiring president. Other new officers are Mrs. Spencer Alexander, Springfield, vice president; Mrs. Emmett Rogers, Salem, secretary; and Mrs. Bertram Dick, Portland, treasurer.

Scholarships: Fulbright scholarship awards for foreign study have been awarded to two OSC graduate chemistry students. Winners are William Fredericks, San Diego, Calif., and Ernest P. Noble, Berkeley, Calif. Travel and study expenses are covered by the grants. Fredericks will study physical chemistry at the University of Leiden in The Netherlands. Noble will do organic biochemistry work at the University of Paris, France.

Named: Dr. John C. Decius, OSC professor of chemistry, was recently named winner of a Guggenheim fellowship to study at Oxford university in England next year. The award is given to scholars "who have demonstrated high capacity for original scholarly

research." Dr. Decius will study forces that hold molecules together. He is the fourth OSC professor honored by the Guggenheim Memorial foundation.

Spring Fever: Spring term ended on the OSC campus with a real honest-to-goodness heat wave. College authorities blamed the mid-summer-like weather for several student uprisings that happened during final week. Over 700 students gathered in the streets near the women's dorms one evening. Mass water fights turned into a full scale "panty raid" on Sackett and Waldo halls. The 300 girls in Sackett had been forewarned, however, and the men found the hall impenetrable. Attention was then turned on the freshmen women's dorm where a few males scaled the walls by the drain pipes and captured "trophies." One student jumped from a second story window but was not hurt. Campus and city police, aided by President Strand and Blue Key, the men's service honorary, were partially successful in quelling the uprising. Fifteen students were arrested on charges of disorderly conduct and after hours after fire hydrants were turned on and police cars stoned. College authorities tried to frighten the students by telling them that their grades were bound to suffer because of the lack of studying. The students didn't seem impressed, however.

Department Heads Change on OSC Faculty

FOUR OREGON STATE professors were advanced to department heads on the OSC faculty. They are E. M. Dickinson, veterinary medicine; Spencer B. Apple, horticulture; H. G. Barnett, electrical engineering, and Arvid T. Lonseth, mathematics.

Stepping down as department chiefs are J. N. Shaw, veterinary medicine; Henry Hartman, horticulture; F. O. McMillan, electrical engineering, and W. E. Milne, mathematics.

Hartman, McMillan and Shaw will continue on the staff as professors in their

departments. Milne retires July 1 and will become professor emeritus of mathematics.

New horticulture department head, Apple, was graduated from Texas A. & M. He taught there nine years before coming to OSC. Barnett, new head of electrical engineering, came to OSC from Westinghouse corporation in East Pittsburgh, Pa., having worked for Westinghouse in Columbia and Manila. He is a 1931 OSC graduate.

Dickinson joined the OSC staff 20 years ago. He worked as head of the experiment station poultry disease research program. Lonseth came to the Oregon State mathematics department in 1948. He has been doing significant studies under grants from the U. S. army office of ordnance research. He was chosen by OSC students as an "inspirational" teacher in 1952.

The retiring department heads have been recognized for their contributions in teaching and research. The Oregon Horticultural society honored Hartman for his "outstanding contributions to the fruit industry" in 1954.

Milne has authored three college mathematics texts and has written scores of papers and journal reviews in his field besides doing research work. He taught at the University of Oregon from 1919 until 1932.

Shaw joined the OSC staff in 1926. He is widely known for his early work on liver flukes and salmon poisoning. He has had more than 50 papers on animal diseases and parasites published.

McMillan was president of the American Institute of Engineers in 1951-52. McMillan has patented a method of shelling nuts with high-voltage. This system has saved the nut industry time and money. He was Oregon's "Engineer of the Year" in 1952.

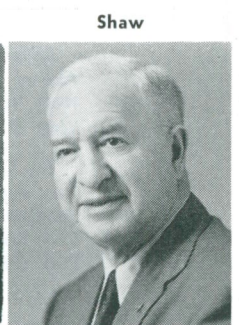

INSIDE OSC

LARGEST snafu in recent years was the one where the Corvallis fire department refused to answer a fire call at the OSC main turkey research building in late April. The result was that the three-wing building, equipment and some 1,400 one and three week old turkey poults were destroyed at a loss of over \$60,000. City officials claim the fire department has a policy of not going outside of fire district boundaries. College officials pointed out that the fire department had gone to other fires on college property and outside the fire district. The college and city apparently had "a gentlemen's agreement" for previous fires but the city failed to notify OSC of it change of policy. Loss of the young turkeys destroyed research projects on turkey nutrition, pedigree breeding and management. It will take two or three years to put projects into operation again.

OSC's tall and talented All-American basketball center, Swede Halbbrook, just didn't have the stuff to make it through college. The seven foot three inch giant failed to "hit the books" enough. Professors kept complaining that the cage star wouldn't attend classes. Another fact is the "Splendid Spire" attended more classes in local pubs, smoked his share of cigarettes even during training. Ticket applications for football games will be sent out between July 1 and 15. The alumni association's program the last year of sending out applications only to members of the association seemed to prove popular. In previous years everyone got an application. While we are on the subject of football we'll predict that OSC will have one of its best freshman teams next Fall. The Beavers will gradually improve as a football power. Head Coach Tommy Prothro got another assistant coach in late June when he was married to a Memphis, Tenn., girl.

The former football staff is now in Portland. Kip Taylor is manager of the Columbia-Edgewater country club. Len Younce is with Equitable Life Assurance, and Ward Cuff accepted a position with Hunting and Fishing News. Ward, an ardent outdoorsman, will lecture and show movies in the Northwest and will work on the magazine. Aside from his job with Equitable Len Younce will be one of the PCC referees in football next year. And a good one he'll make too. An interesting angle is that Len has been assigned to be an alternate ref and handle the box at two Oregon State games next Fall.

Look for happy carillon music to ring out over the campus next year. Members of the older classes are privately trying to raise enough money to have the carillons installed in the M.U. by September. Mr. John Gallagher, class of 1900, is spearheading the project. About \$7,000 is needed for the first unit.

Look for the best student spirit in a number of years to be evidenced during 1955-56. The rally squad has already been making intricate plans to spark the student body. A gigantic Portland rally and parade before the Stanford game is in the making. If the OSC football team clicks at all next season the students will have something to rally around. Yell King Phil Carlin has gathered together the six best-looking girls we've seen in many a moon. It will be an interesting year for sure.

Graduation

OREGON STATE'S 86th annual commencement was recorded in the college's history as 1,006 students received 1,021 doctor's, master's and bachelor's degrees at the exercises June 6.

Bright sunshine added extra color to the long traditional academic parade across campus and down to the coliseum. The weather was in sharp contrast to a year ago when heavy rains washed out the procession at the baccalaureate service and gave some anxious moments before clearing on commencement day morning.

A record number of doctor's degrees, 52, and master's, 213, were conferred by President A. L. Strand. A total of 741 seniors received bachelor's degrees. One of the doctor's degrees was a post obitium award. It went to the late Vernon Duiker of Volga, S. D., who was killed in a January automobile accident while in his final weeks of advanced study in zoology.

Sixty-five OSC students were designated as honor graduates at the commencement exercises. These students earned a grade average of at least 3.25 points during their college career. A total of 123 seniors took the oath of office as new lieutenants and ensigns in the air force, army, marine corps and navy following conferring of degrees by Dr. Strand.

Reunions

MORE THAN 250 alumni gathered on campus June 4 for the annual reunion of classes. Classes of 1905, 1915, 1930, and the Golden Jubilee association returned from many parts of the country to visit, reminisce, and tour the campus.

Each class sponsored a luncheon and conducted its own program for the day. That night the reunion classes met together in the Memorial Union for a banquet and to hear President A. L. Strand.

Head Basketball Coach A. T. "Slats" Gill acted as toastmaster during the banquet. Alice Jones Thomas, '05; Howard Belton, '15; and Chet Hubbard, '30, gave short speeches for their classes.

Honored

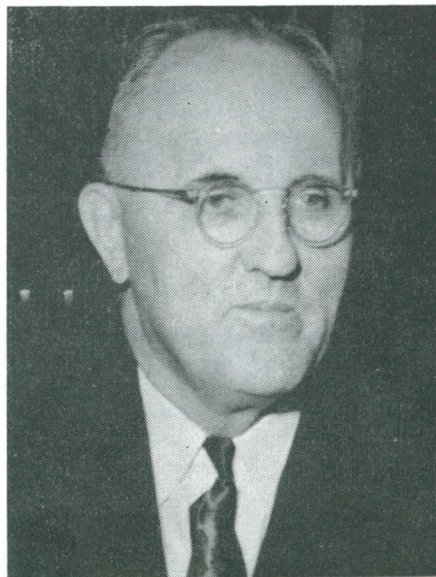

Honored for his inspiration

Bill Langan, agricultural student personnel adviser, was honored May 21 by a number of his former students at a dinner at the Mallory hotel in Portland. Langan was feted by the group for his interest and inspiration given the students. The event was an unusual tribute because of the affair's spontaneity and because usually events such as this happen only after the guest of honor retires.

Mainwaring Appointed to Board

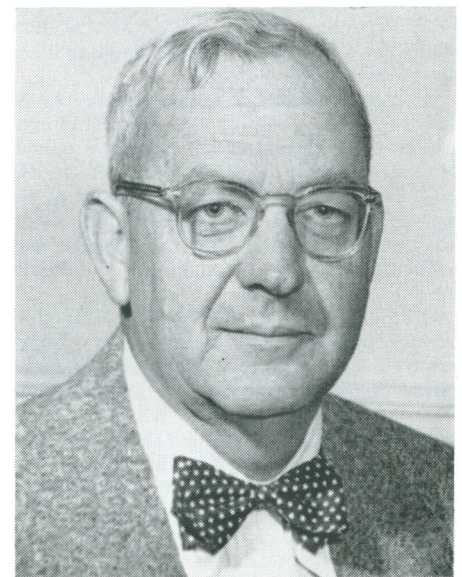


Bernard Mainwaring

President of Corporation



William Watters
Hunting for uranium

PRESIDENT and director of the new Amuranium Corporation of Washington, D. C. and Moab, Utah is an Oregon Stater named William H. Watters, '16. The corporation was set up in 1954 to engage in the exploration, acquisition, drilling and mining of uranium properties in Utah.

Mr. Watters was graduated from OSC in 1916 with a degree in mining engineering. While at OSC Watters was a fine 157-pound wrestler and was elected captain of the mat squad. Now in this latest mining venture Watters is in charge of Amuranium's field operations out of the Moab, Utah office. At the present time the Amuranium Corporation

is drilling and conducting exploratory mining for uranium only a few miles north of the major discovery in 1952 by Charles A. Steen. The area now being explored is believed to be the most promising region in America for new uranium discoveries. Nearly 95 per cent of the uranium so far produced in the U. S. has been found there.

Bill Watters' internationally outstanding reputation as a mining engineer comes with years of mining experience in many parts of the world.

He started as a mucker underground in Idaho and has been mining continuously ever since except for 19 months of army service in the U.S., France and England during the first World War.

Watters was employed by the Pacific Tin Consolidated in the Federated Malay States, immediately north of Singapore as a junior engineer, superintendent, and assistant manager for a period of nine years. Between Malayan contracts, he assisted with the examination of the Patino mine in Bolivia, the world's largest lode tin mine. For 11 years he managed three dredging companies with headquarters in Sacramento, California.

More recently, Watters was field manager of Pato consolidated gold dredging Ltd. in Columbia, South America for 4½ years.

This latest venture for uranium seems destined for success. Under the direction of Watters discoveries have been made of small amounts of oil and gas. With uranium mines in the area covered by the Amuranium Corporation now reported to be worth between \$50,000,000 and \$150,000,000, the chances look very promising for William H. Watters and his new mining project.

We have great respect for Tommy, both as individual and as a football coach. He has a sound, solid staff with which to work. If the players can learn as much as Tommy can teach them, Oregon State football definitely will be on the upswing, after experiencing its low ebb in 57 years of the sport.

It might be interesting to list a few of the men who played the most in spring practice. Naturally the lineups might change, but it will give you a slight inkling of what to expect. The first unit last spring was composed of Norm Thiel and Bob DeGrant, ends; John Witte and Howard Buettgenbach, tackles; John Sniffen and Bob Riggert, guards; Larry Stevens, center; Ron Siegrist, blocking back; Joe Francis, tailback; Sam Wesley, wingback; and Tom Berry, fullback. Of this group, DeGrant, Francis and Wesley are sophomores-to-be. Thiel, Witte, Sniffen and Berry are juniors, while Buettgenbach, Riggert and Stevens are seniors.

Let us emphasize again that this lineup is by no means the starting eleven for next Fall. Dan Naranche, a transplanted fullback, could well move DeGrant out at one of the end positions. With all his natural football ability, Ray Westfall easily could move in

Prothro isn't interested in large numbers of men on his squad, but he does expect some quality instead of quantity.

Generally speaking it looks as though the Beavers will be strongest at tackle, weakest at center and in the linebacking departments, fair at tailback and wingback and fair at ends. Fortunately for the inexperienced men,

the team doesn't play any midwestern inter-sectionals this time, although the Beavers do open the season against Brigham Young from the Skyline conference. They take on every Pacific Coast conference member, with the exception of Southern California, and meet BYU and College of Pacific in kings-x encounters.

We look for it to be an interesting year. Beaver fans, anxious as they are for a winning season after several lean ones, certainly do not expect miracles of Tommy Prothro and his capable assistants in their first year here. If Tommy gets the players, he'll build them into a winner.

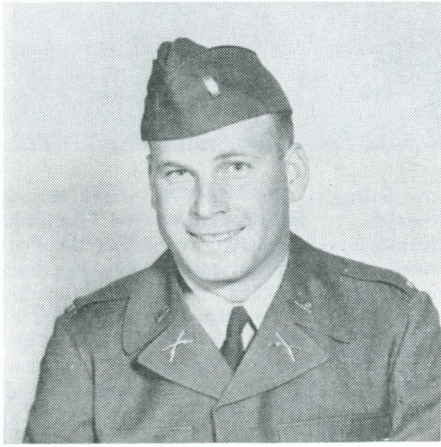

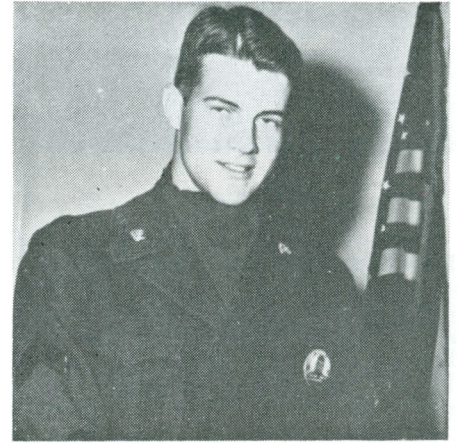

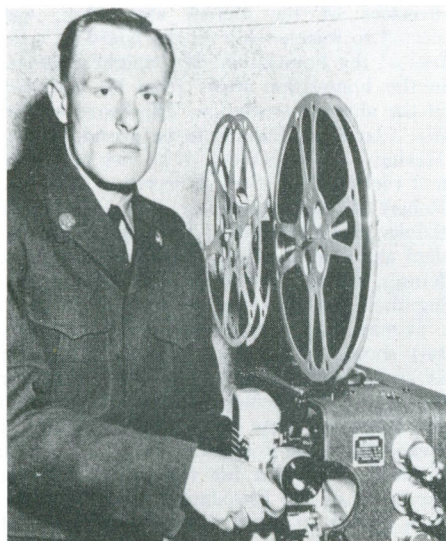

Year in Review Shows Foundation's Progress

Dear Oregon Stater:

WITH this issue of the Stater we come to the end of almost a complete year of activity for the Foundation. I say almost a complete year because my work with the Foundation started on the 16th of July, 1954. With this letter I hope to review and report on what has been done during that time.

Specifically, mention should be made of the following accomplishments:

Establishment of the first Foundation Scholarship.

The Louis W. and Maud Hill Family Foundation grant.

The fund drives: development, sustaining, Peckstein, and General Electric.

An additional member of the Board of Trustees.

Election of Officers for the Foundation.

The reappointment of the Executive Secretary.

The above listing is in relative order of importance but is not in the order of accomplishment. Perhaps a review of the year's efforts in a more orderly fashion will develop the picture better.

"Like a ship without a rudder" our Foundation can accomplish nothing unless there are funds with which to work. The first order of business, then, was to begin the development funds. This, as you will recall, was initiated in the Oregon Stater and carried on throughout the year by appeal, both in writing and by direct approach, to any and all who would care to help. From this the Foundation received from 18 contributors the sum of \$420.

When you stop to consider it carefully, it is apparent that it takes money to make money. Our Foundation is no exception. In order to invite contributions to help in this part of the work, the Board of Trustees amended the by-laws of the Foundation to include as "sustaining members" all those who contribute one dollar or more to the sustaining fund. To start off this sustaining fund one alumnus, who desires to remain anonymous, contributed \$1,000. A direct appeal, by letter, was made to all of the present paid up life members of the alumni association. Over 1,300 letters were sent out between the 22nd and the 30th of April. The first reply came in on Tuesday, the 26th of April, and up to this date (15 June, 1955) there has not been a day when mail has been delivered that at least one return has come in. In this time there have been 159 contributors to the sustaining fund with a total of \$2,550.27. This, when coupled with the \$1,000 mentioned above, gives the Foundation \$3,550.27 in this fund.

I have mentioned from time to time in these letters the needs of the various schools on the campus and started those reports with the one for the School of Home Economics. Thinking that as a start it would be relatively easy to raise \$350 for an oil painting, the Peckstein oil fund was begun with a contribution of \$31 from the staff of the family life department of Home Economics. In answer to the appeal in the Stater two alums sent in \$7.00 and just this week one of the graduate assistants in the nursery school gave me two checks for \$5.39 which represented pay to her for "baby sitting" with the child in one of the home management

houses during a vacation period. Since, when acquired, the painting will be hung in one of the home management houses her gift has special meaning. This fund now has \$43.39 in it.

The General Electric Corporate Alumnus Program came along in December, to apply during 1955, and Dr. Strand gave me the preliminary literature on it. A letter was drafted to those Oregon Staters who are members of the General Electric family seeking contributions for the college through the offices of the Foundation. Before this letter could be mailed, information was received which indicated that all contributions had to be acknowledged by the "highest financial officer" of the institution in order to qualify for the matching program. This meant that the funds became state property upon acceptance and, of course, could not come to the Foundation. The letter was re-drafted along these lines and sent out at Foundation expense. The response has been disappointing in numbers and gratifying in amount. There have been four contributors (from a possible source of some 200 alums) with a total gift of \$635. Since General Electric will match these dollar for dollar the fund is now worth \$1,270. In this issue of the Stater there is a picture of the executive secretary handing the college business manager the first matching check received from General Electric as a result of the first contribution made to the fund by Donald W. Halfhill, '43, now living in Marblehead, Mass.

The Louis W. and Maud Hill Family Foundation grant to the Foundation is unique in one respect. It entrusts to our Foundation funds to be used for scholarships in any accredited college, university, trade, commercial or vocational school in Oregon. There are six \$300 entering freshman and two \$500 undergraduate scholarships in this category which may be used in any such school in Oregon. In addition to this our School of Forestry benefits by three \$500 undergraduate scholarships, a \$1,400 graduate fellowship, a \$3,000 visiting professorship, and a generous sum to carry on extension classes

in adult education in the Sweet Home area. A condition of the grant was that, in addition to administering the scholarship and extension program at Oregon State, the administration of the funds to pay for scholarships at other institutions be a part of the program. Oregon State is fortunate in having the Oregon State College Foundation to do this since Dr. Strand is of the opinion that the conditions of the grant could not be met if the college had been called upon to administer it. This program is known as the South Santiam Educational and Research Project.

Aside from the normal press releases which were handed out to the news media at the time of the \$32,970 grant and which were published in our papers, there appeared the following editorial comment in the Oregonian of Monday, June 6, 1955:

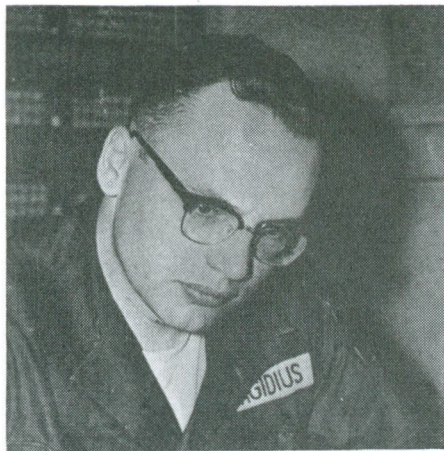
"The whole three-year package will cost less than \$33,000. The prospective benefits to forestry in Oregon can be estimated as many, many times that figure. The program is illustrative of the bargains that exist in the field of education. A relatively modest bequest, if well planned, can pay astonishing dividends."

You will note that I have listed the establishment of the first Foundation scholarship in relative order of importance above the Hill Family Foundation grant. This is not done to belittle in any way the importance of the Hill grant but is done to point up the importance of the Foundation being able to give a scholarship from funds raised directly from friends and alumni of the college. It is, I think, an important milestone on our road of progress and should be but the beginning of many, many more to come. Our purpose of "furthering educational opportunities at Oregon State" can have no finer expression than in assistance to the youth of the state in preparing themselves for their rightful role of leadership in our state and nation.

At the annual meeting of the board of trustees on June 4, 1955, Mr. Lindsey H. Spight, '25, a successful radio and public relations executive of Orinda, Calif., and former (1950-53) member of the board of directors of the alumni association, was elected to membership on the board of trustees of the Foundation. Mr. Spight's interest in the Foundation stems from his activities in the alumni association. The board elected Mr. Claude F. Palmer to be president, Mr. Marion T. Weatherford to be vice president, and reelected Dr. Strand, secretary, and Mr. Robert M. Kerr, treasurer. A rising vote of thanks was tendered to the outgoing president and vice president, Mr. Bauer and Mrs. Kinser, for the fine work accomplished during their tour of office.

It may seem odd that the executive secretary should list the reappointment of himself as an accomplishment of the Foundation for the year just concluded. When viewed from the point of view that his reappointment means that the Foundation is in a position to carry on with a full time person serving the needs of the Foundation and the college, it is indeed an accomplishment. It means, I think, that our Foundation is off to a good beginning and, if Oregon Staters follow the trend established by other state supported institutions, we have entered a period in our

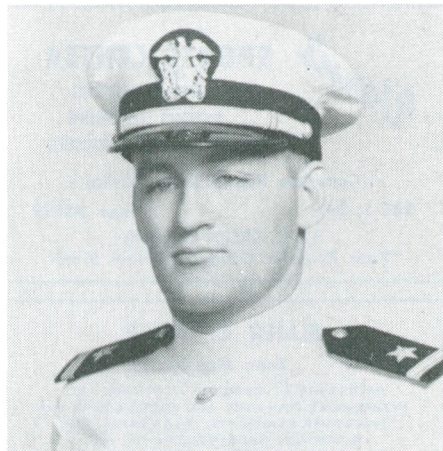

Dr. Helmer Named Associate



Dr. Oscar Helmer

Outstanding contribution to research

DR. OSCAR M. HELMER, 32, was recently named research associate of Eli Lilly and Company of Indianapolis, Ind. in recognition of his outstanding contributions to research.

Dr. Helmer's work with the etiology of hypertension led to the discovery of Angiotonin, the postulated pressor substance which causes hypertension. He has been associated with the Lilly research laboratories since 1931. As department head of clinical biochemistry in the clinical research division, he was engaged principally in medical research and physiological chemistry.

In addition to hypertension, his fields of interest include gastric studies; pernicious anemia; vitamin studies in human beings and animals, including vitamin B-6 and nicotinic acid deficiency; and cancer research.

Dr. Helmer is a native of Portland and was graduated in 1918 from Portland's Lincoln high school. After graduating from OSC in 1922 he received his master of science degree in 1924 from the University of Illinois, and his doctor of philosophy degree in 1927 from the University of Chicago. Before joining Lilly's he spent four years in cancer research at the Rockefeller Institute for Medical Research.

The OSC alumnus is a member of the American Society of Biological Chemists, American Chemical Society, Central Society for Clinical Research, American Federation for Clinical Research, Society for Experimental Biology and Medicine, Society of the Sigma Xi (scientific honor society), Alpha Chi Sigma (professional chemistry fraternity), and Gamma Alpha (graduate scientific recognition society). A fellow in the American Association for the Advancement of Science and an honorary member of the Indianapolis Medical Society, he is an associate professor of experimental medicine at the Indiana University School of Medicine.

Oregon State's entomological collection has passed the 200,000 specimen total. The insects are used daily by OSC students and staff members for study.

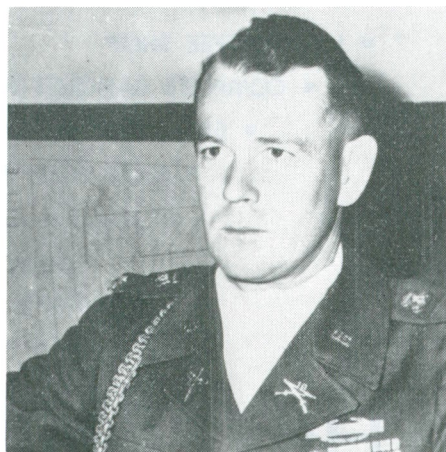

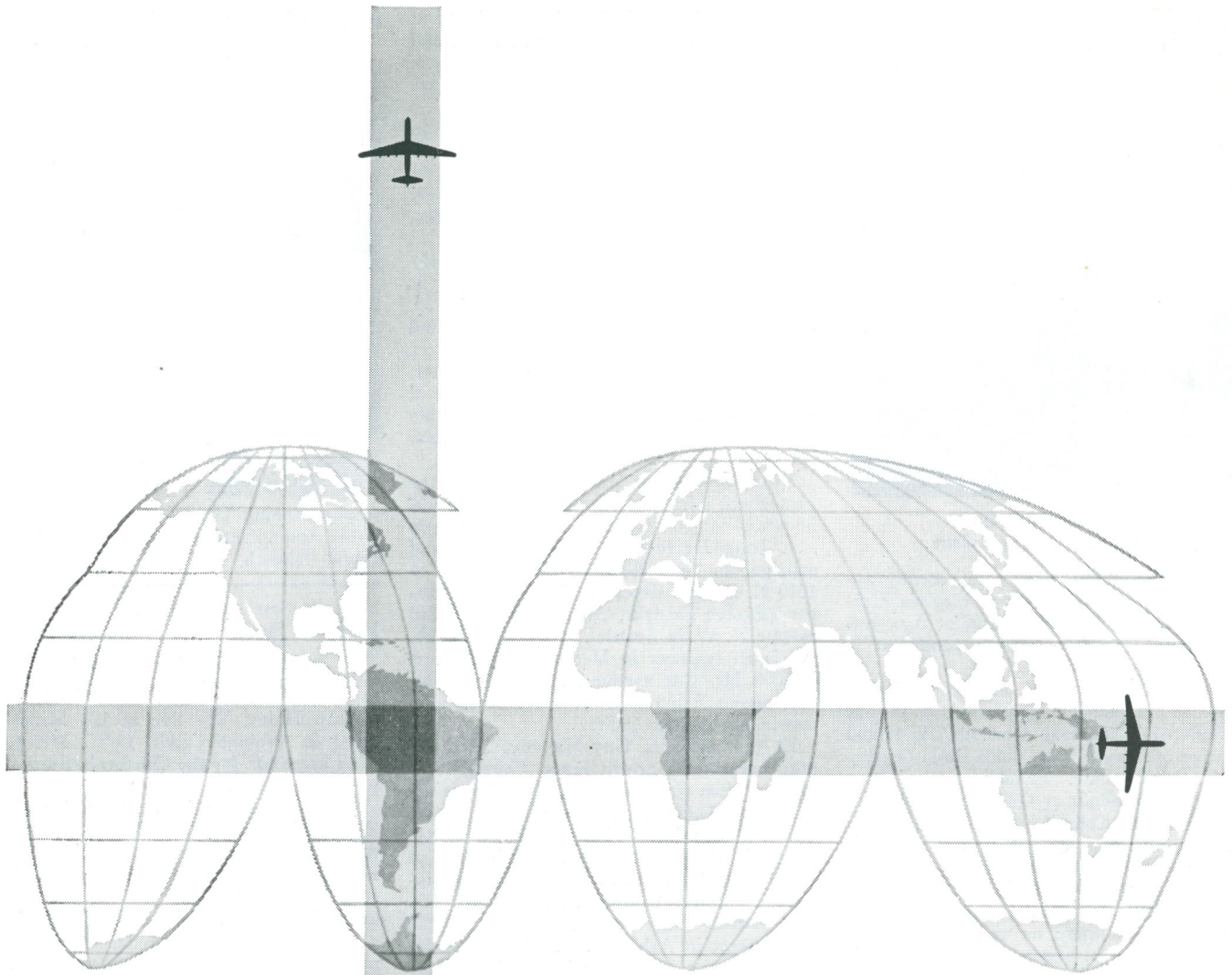

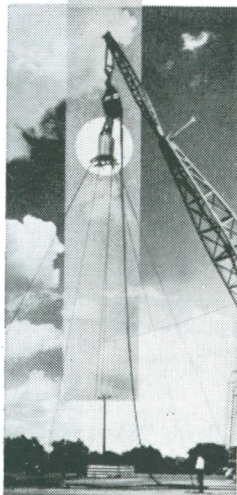
