A. Ph. A. to Convene in Portland

First National Meeting Held in Northwest
Scheduled for August 5 to 10

THE annual convention of the American Pharmaceutical association will be held for the first time in the Pacific Northwest August 5 to 10 in Portland.

Although it has been established for over 83 years, never before has the group convened in this area.

Both the scientific and practical standpoint of the profession will be discussed by members of the body during the convention who will meet in the Multnomah hotel. The first assembly will be in the nature of a joint banquet on the night

of August 6 intended to assemble the delegates of the A. Ph. A. and related organizations as well as those of the tri-state convention which will convene officially August 4 to 6.

The actual program begins Wednesday, August 7, and the activities of the various sections will be published in the program. This will include sections on commercial interest, the scientific section, practical pharmacy and dispensing, and all other types of discussion that may be of interest to the various groups of delegates in attendance.

The American Pharmaceutical association is the professional organization of pharmacists and was established in 1852. A few years ago it was decided to erect a headquarters building where the various activities of the association could be centralized and where its valuable historical possessions could be preserved. A fund for the purpose was collected to which approximately 14,000 pharmacists and others interested subscribed. By a vote of its members, it was decided to locate the building in Washington and a wonderful site on Constitution Avenue opposite the Lincoln Memorial was obtained. The Commission of Fine Arts, the Capitol Park and Planning commission, the commissioners of the District of Columbia and other governmental officials have cooperated in enlarging the site, and in the planning and locating the building, since it and other buildings facing on Constitution Avenue form the frame for the Lincoln Memorial.

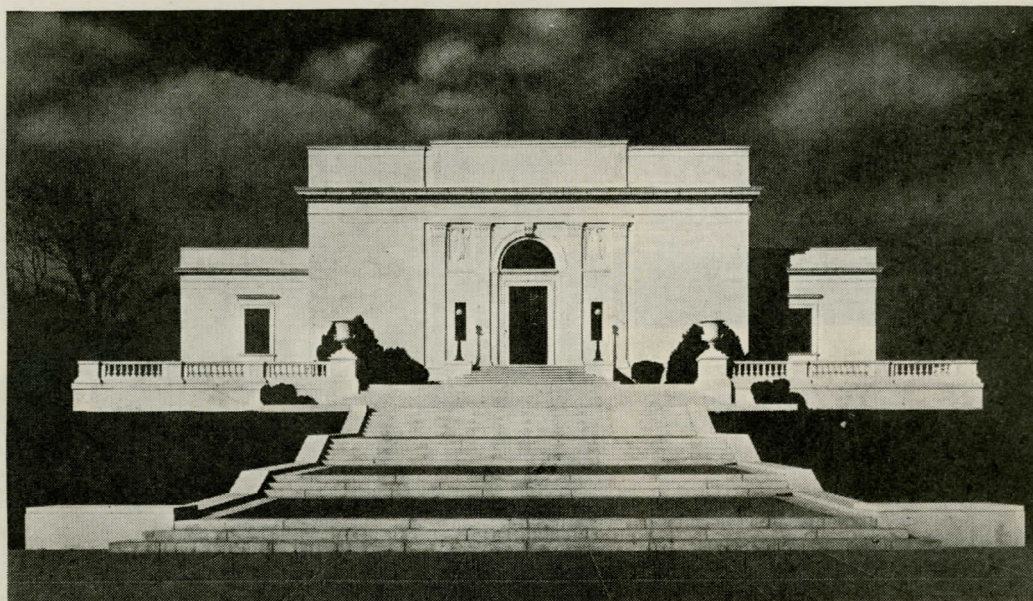

The Stage Is Set for Tri-State Meet

First Convention of Three Northwest Associations to Be in Portland

THE state pharmaceutical associations of Idaho, Oregon and Washington will hold a tri-state convention at Portland on August 4 to 6 inclusive, which will add greatly to the interest and attendance of the American Pharmaceutical association convention.

The headquarters will be at the Heathman hotel, but the joint meetings will be held in the Masonic Temple, in which will be housed the fifty-one exhibits of the Pacific Northwest Drug Show.

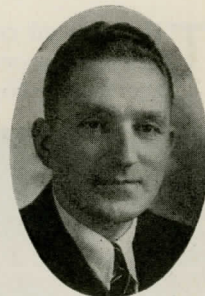
On Sunday, August 4, the tri-state group will assemble at the Oswego Country club for entertainment in the form of golfing, swimming, boating and various other entertainments. On the evening of the same day it is planned to hold a meeting to honor the tri-state presidents and to discuss plans for the meetings. It is believed that the tri-

state convention is the first one of its kind ever to be held in connection with an American Pharmaceutical Association convention. In addition to the joint meetings of the associations, each group will meet to discharge their various duties such as the reports of committees, election of officers, and other details.

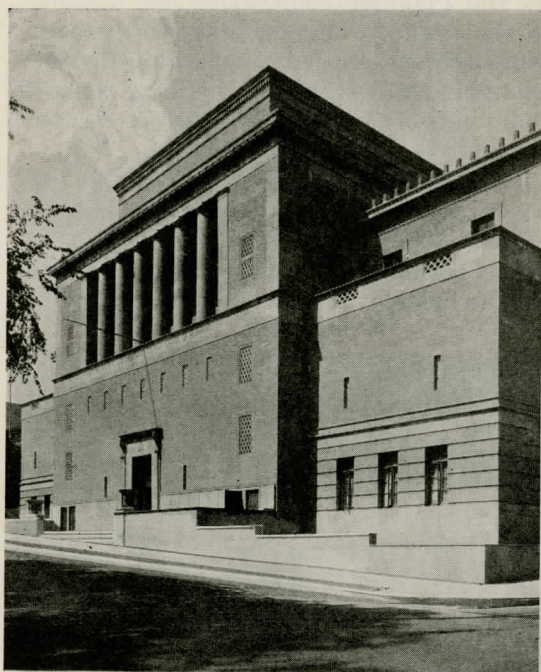
On Monday evening the tri-state group will hold a banquet at which time it is expected that Carl Weeks, or some other nationally known drug merchandising expert, will be the principal speaker.

The Drug Exposition will consist of 51 booths which have been reserved by national and local firms for exhibits. These exhibits will be open to the public at certain hours. There will be generous gifts of merchandise and favors.

The idea for the tri-state convention was formulated by Roy A. Perry, president of the Oregon State Pharmaceutical association, and his committee. Without question, Mr. Perry has been one of the most outstanding presidents of the Oregon State Pharmaceutical Association since its inception in 1899. Throughout the year he has devoted a great deal of his time to formulating plans for the association and for the first time in the history of the state, he held three quarterly meetings, which were outstanding in every respect. In addition, Mr. Perry was active in the enactment of laws by the last session of the state legislature which will be of inestimable value to pharmacists.

Alumni Pledge Support to Dr. Kerr

Recommendations Adopted Concerning Group Reorganization

THE annual business session of the Oregon State College Alumni association held on the campus during commencement weekend saw the adoption of a resolution giving W. J. Kerr, chancellor of higher education, the support of the organization and the passing of several recommendations for reorganization of the association. A budget for the coming year was adopted which will require diligent effort toward increasing the membership of the body.

The recommendations passed provide for a full-time secretary to be employed by the association to devote his time to development of the organization; that a continuance of FERA student labor be requested for the coming year; that a detailed cost study of the ten issues of the Oregon State Monthly for 1934-35 be prepared and copies sent to members of the board and that a strong effort be made to place the magazine on a self-supporting basis.

Officers elected by the association for the coming year are J. C. Plankinton, '10, of Portland, president, who succeeds David Wright, '08, of Salem. George Wernmark, '30, of The Dalles was named vice president, and A. K. Berman, '07, Corvallis, and E. C. Allworth, '16, Corvallis, were retained as treasurer and secretary, respectively.

The resolution adopted by the association in regard to the recent attack made upon the chancellor by various groups throughout the state is given here in its entirety:

"The disturbing influence on higher education caused by the biased report of three professors of the American Association of University Professors and distributed by two University of Oregon faculty members is deplored by the alumni association of Oregon State College. As already pointed out by the press of the state, the release of the report serves no useful purpose. It is an unwarranted attack upon the state

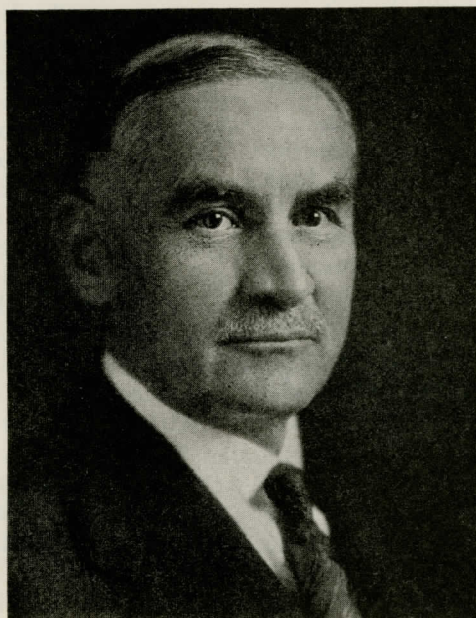
board of higher education and tends to continue turmoil and strife after substantial progress has been made toward the attainment of harmony.

"The report disregards the fundamental purposes of higher education, service to the state and its youth, and sets up the idea that the system should be run to please disgruntled professors.

"As to the attack upon Dr. Kerr, his sterling character and record of nearly 30 years devoted and unselfish service to higher education in Oregon is its own defense.

"This association believes the people of Oregon are tired of strife, bickering, and turmoil in higher education. The harmonious action taken last week by the Portland alumni chapters of both the university and the college in issuing a joint statement in support of the present system is an example of effective cooperation that should be fostered. We appeal to the alumni of all institutions, to parents and friends of education to lend their influence to prevent such

Irvine Bust Placed in M. U. Lounge

Testimonial Bronze Cast of Editor
Dedicated at Commencement

THE testimonial bust of B. F. Irvine, editor of the Oregon Journal and for more than 30 years a leader of higher education in this state, was dedicated and placed permanently in a prominent corner of the Memorial Union lounge during commencement weekend. Mr. Irvine termed it as one of the "greatest honors of my life" when he made a brief talk at the dedication ceremony.

The bust was a gift to the college from thousands of Mr. Irvine's friends from all over the world, who had a part in presenting the editor's likeness to the college and whose names filled three large volumes which were turned over to Mr. Irvine by Charles Stidd of Portland, chairman of the event.

The testimonial to Mr. Irvine culminated in an impressive program at the Benson Polytechnic high school in Portland late in February when the bronze bust of the blind editor was unveiled before an enthusiastic audience as a feature of a beautiful ceremonial.

The bust, sculptured by Adrien Voisin, internationally recognized artist, and cast in bronze by New York silversmiths, was not only made from life but is life size. Stidd, general chairman of the testimonial committee, introduced the program held in Portland and paid a graceful compliment to Mrs. Irvine, daughter of the pioneer family that founded Corvallis.

Stidd headed the presentation program during commencement and told of the early life of Mr. Irvine, recalling his early days as editor of the Corvallis Gazette, his term as mayor of Corvallis and his connection for the past 37 years as a member of the col-

lege board of regents or the state board of higher education. Stidd again paid tribute to Mrs. Irvine for her "fine life and glorious citizenship" and as one of Oregon's really great women.

Governor Charles H. Martin was on the campus for the dedication and praised the editor for his battles for the cause of justice and added that Mr. Irvine had never taken undue part in unnecessary feuds "in which I think we have engaged in too many in Oregon."

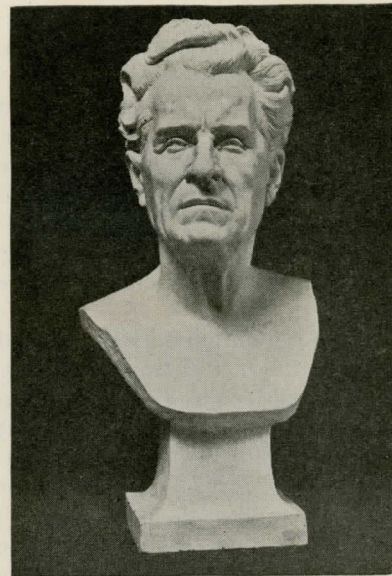
Although Mr. Irvine is a graduate of the University of Willamette, his work in higher education has been chiefly in the state institutions and particularly with Oregon State college.

In 1927 the college conferred the degree of doctor of laws upon Mr. Irvine as a symbol of its gratitude for the outstanding service he has rendered the Beaver school. Always interested in campus affairs and often a convocation speaker, the Portland editor is a friend of the students, alumni and faculty of this college.

Recognized as one of the foremost newspaper men in the United States and having been honored in eastern parts of the country for his civic service and professional interest, Mr. Irvine is one of the state's leading citizens who is nationally known as scholar, author and orator and is an honest humanitarian of practical but inspired ideals.

When Mr. Irvine received the honorary degree, Dr. W. J. Kerr, then president of the college, termed him a scientific student of civic and economic problems.

Oregon State is proud to list Mr. Irvine in its group of friends.

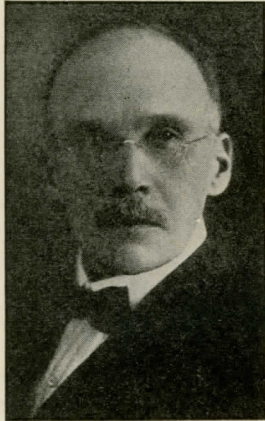


THE TESTIMONIAL IRVINE BUST

Three Prominent Veteran Druggists



S. A. MATTHIEU of Portland is one of the outstanding veteran drug store owners in Oregon. After completing his secondary school work in Butteville, Oregon, Mr. Matthieu prepared for his college course. Due to a serious accident to his father, he was obliged to take care of the farm until June 10, 1881, when he accepted a position with the Woodard-Clarke Drug company as general assistant in the store. Later he accepted a similar position with Snell, Heitschu, Woodard company as their city salesman and held a similar position with the Blumauer-Frank Drug company.

Mr. Matthieu attended Oregon State college in 1879 and is the son of F. X. Matthieu, who was the longest survivor of the group that established a provincial government at Champoeg, May 2, 1843.

Mr. Matthieu has been actively engaged in the drug store business at the present site for 41 years. He is one of the three surviving members of the group that established the Oregon State Pharmaceutical association in Portland in 1889 and since has been active in all association work designed to improve the status of pharmacy. He has held the position of president of the Oregon State Pharmaceutical association, Portland Retail Druggists' association, the O. S. P. A. educational fund, which is the name of the School of Pharmacy student loan fund, and is one of the charter members and has also served as president of the Druggists' Cooperative association.

Mr. Matthieu has contributed his share to civic work and was a representative from Multnomah county in the state legislature in the 1917 session. He has also acted as delegate to several National Republican conventions.

His father, F. X. Mathieu, was one of the best known men of his time in Oregon and served as a national delegate to several organizations.



GEOURGE C. BLAKELEY, one of the three surviving members of the group that established the Oregon State Pharmaceutical association in 1889, on May 24, 1933, completed his forty-ninth anniversary as proprietor of the George C. Blakeley & Company drug store, doing business in the same location.

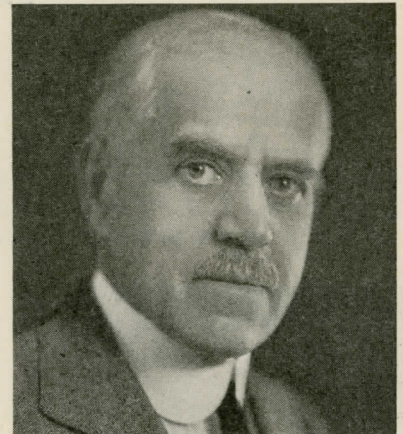
The outstanding reputation of this store stands as a fitting memorial to a man who devoted almost 50 years of his life in public health service to the public. Mr. Blakeley served his apprenticeship in pharmacy in eastern states and for five years before coming to The Dalles acted as sales representative for Frederick Stearns & Company, with offices at San Francisco.

Having served eight years as judge of Wasco county, Mr. Blakeley is known to all of his friends as Judge Blakeley. In the earlier years he was one of the most active workers in pharmaceutical legislation and his work with the state legislature stands as a monument to his constant effort in behalf of pharmacy in Oregon. He was the second president of the Oregon State Pharmaceutical association and served for ten years as a member of the Oregon State Board of Pharmacy and one year as president. He is a life member of the American Pharmaceutical association and the O. S. P. A. and has served on the federal grand jury. He is one of the best-known business men in his section of the state.

One of Judge Blakeley's greatest joys is to note the progress of the many young men whom he trained who have become leaders in business and the professions.

LOUIS G. CLARKE, one of the three surviving charter members and third president of the Oregon State Pharmaceutical Association, was graduated from the Philadelphia College of Pharmacy in 1875. The next year he came to Portland and for 59 years has been a constructive force in the pharmaceutical development of the state.

Mr. Clarke was founder of the Woodard, Clarke Drug company, and for 50 years its president. In many respects this drug store was unique because of the varied types of services rendered and the efficient manner in which the business was conducted. Throughout the history of this organization the owners maintained a high code of ethics as outlined by the American Pharmaceutical association.

In addition to the retail drug store, for 25 years Mr. Clarke was associated with William F. Woodward in a wholesale division of the business known as the Clarke-Woodward Drug company.

Mr. Clarke was one of the organizers and first president of the Oregon State Board of Pharmacy. He was instrumental in organizing the Oregon Mutual Life Insurance company of which he has served as president, vice-president and director. For five years he was president of the Oregon Tuberculosis association. He is a member of the Crawford Student Loan Fund in Portland, and he has been engaged in many other civic enterprises.

Mr. Clarke has always been an active member of the Masonic Lodge, and has attained the enviable distinction of being a thirty-third degree Mason. In October, 1929, he became Oregon's leading Mason, having been appointed Sovereign Grand Inspector-General of the Ancient and Accepted Order of Scottish Rite in Oregon.

Because of his outstanding civic work, the Oregon State college at the 1934 commencement conferred upon Mr. Clarke the honorary degree of doctor of laws.

The Pharmacist's Code of Ethics

Explanation Given as to What to Expect
from the Oregon Druggist

IN 1852 the American Pharmaceutical Association adopted a code of ethics which with minor revisions, designed to meet the needs of changing conditions,



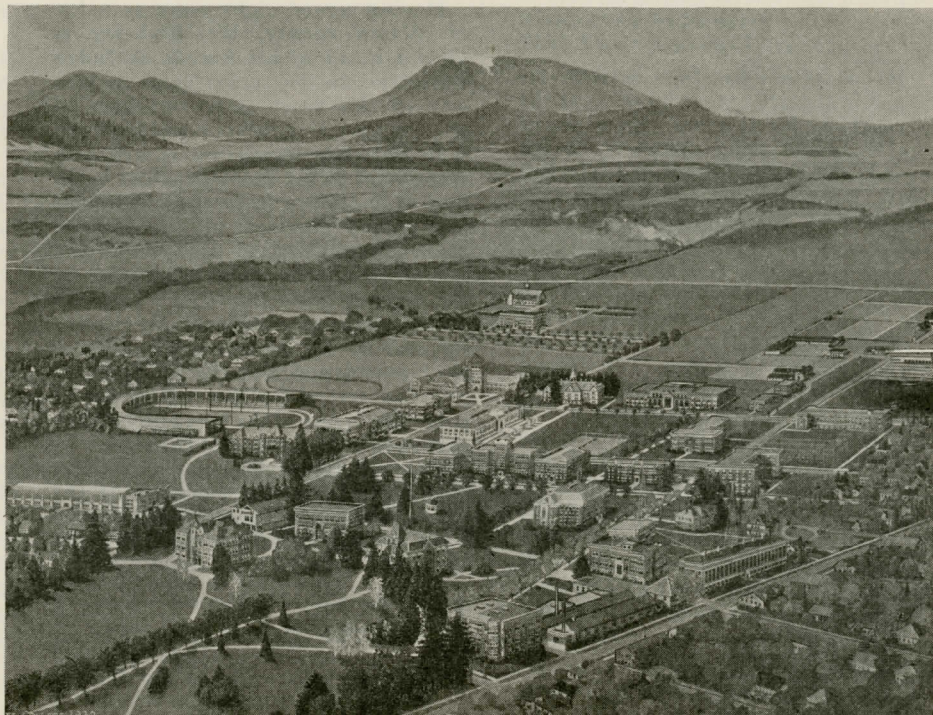

familiar Biblical expression, "As he thinketh in his heart, so he is."

The type of service that the pharmacist renders the people of America has tended to obscure his high professional standing. We look upon the pharmacist and pharmacy in a light different from that of any other profession or institution. We have grown to expect, until we now accept as our right, a service in a drug store that we do not expect from any other institution. How many times have you passed by all other places to ask a question, obtain a service of obligation from the pharmacist? You feel that you are privileged to do so. But how about the pharmacist? Does he fence himself in with formal pretensions that cultivate a sense of profes-

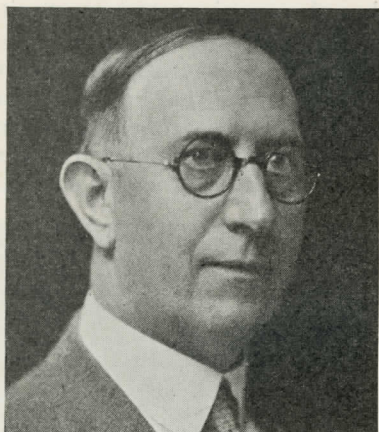
sional aloofness? No, the Code of Ethics directs him to meet you at all times, day or night, ready to serve even though this service may result in a loss to him. Like the physician and the nurse, a pharmacist is a public health servant and he must therefore be ready to render an efficient service to prevent and alleviate sickness. Because of the variety of service rendered by a pharmacist we sometimes forget that he is a trained specialist. In recent years we have seen the old apothecary shop develop into a modern pharmacy. This does not mean that there is less professional skill but that the pharmacist has abandoned the method and equipment of by-gone days. As a matter of fact the pharmacist of today is a highly trained professional man. While the pharmacist is a professional man, he is also of necessity a merchant. A population of at least 11,000 people are required to support a strictly prescription pharmacy such as all pharmacists would prefer to operate. In order to support a complete prescription department and to render all of the services required of a pharmacist, he must engage in merchandising to maintain his establishment. Through the passage of stringent laws it is the pharmacists themselves who have been in-

Some Types of Successful Alumni



JOHN F. ALLEN, '95, of Corvallis, has recently been reappointed a member of the Oregon State Board of Pharmacy by Governor Martin, to serve until May 20, 1940.

After graduation from the college Mr. Allen engaged in the drug business in Portland with his brother, the late Alonzo W. Allen. In order to gain more experience, for two years he acted as sales representative for several eastern drug manufacturing firms, and covered the Oregon territory. About 1905 Mr. Allen moved to Corvallis to relieve his aged father who was owner of the Allen and Woodward Drug Store that was established in 1855. Later Mr. Allen became sole owner of the store which is housed in Mr. Allen's building, and is rated as one of the most up-to-date drug stores in Oregon.

Both Mr. Allen and his brother Alonzo were active in pharmaceutical association work. John is favorably known throughout the United States as the father of the Oregon State Pharmaceutical Association Educational Fund, which is the legal name of the school of pharmacy student loan fund. Mr. Allen presented his needs for this fund to the Oregon druggists assembled in convention at Corvallis in July, 1925, to dedicate the new pharmacy building.

His plan met with such general approval that in ten minutes \$6500.00 was subscribed. Since that date the fund has grown so that financial assistance to worthy students of the school of pharmacy is assured for many years. Since the inception of the educational fund, Mr. Allen has acted as treasurer and general manager.

For many years he has been active in the passage of legislation designed to raise the standards of pharmacy. He has served five years as a member of the Oregon State Board of Pharmacy of which he has acted as president.



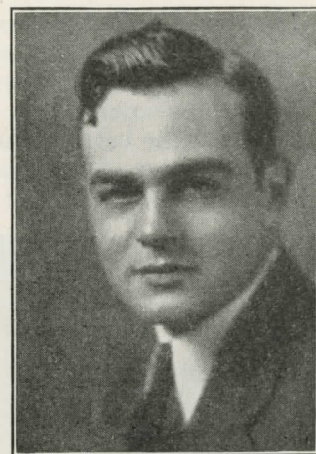
DR. WARREN E. FORSYTHE, '07, is a representative type of over one hundred physicians who prepared for the study of medicine in the school of pharmacy at Oregon State college. Dr. Forsythe has repeatedly stated that his pharmaceutical training was of inestimable value to him in the study and practice of medicine.

Dr. Forsythe was born in Joseph, Oregon, and after completing his course in pharmacy matriculated at the University of Michigan where he was granted the degree of doctor of medicine in 1913. He continued his studies at John Hopkins university and was granted the degree of public health in 1925. He interned at the University of Michigan hospital and was later appointed house physician.

He accepted a position as staff physician with the University of Michigan health service and later was director of health service at Pennsylvania State college. In 1917 he received a commission from the International Health board to study the hook-worm disease in South America. Immediately after completing this work he was called back to the University of Michigan to act as professor of hygiene and public health and director of the university health service, which position he has held from 1917 to date.

The University of Michigan was a pioneer in safeguarding the health of its students, and without question, the Michigan health service is one of the outstanding service of its type in the world.

He is a member of the American Medical association and related organizations, as well as of three honorary scientific fraternities, and one social fraternity. He has published extensively and his reports on health service work have served as a standard in the United States. He is listed in "Who's Who in America" and "American Men of Science."



HENRY F. DE BOEST, '30, is an outstanding type of the 35 graduates of the school of pharmacy who are acting as sales representatives for eastern drug manufacturing firms.

After graduating from the college Mr. DeBoest gained a few years of practical experience in the Capital Drug store at Salem and then accepted a position as sales representative with the Eli Lilly company and traveled in the Willamette valley district. Because of the success in dealing with physicians and pharmacists he was called to the home office of his company at Indianapolis for special instruction. At present, he is working in the Portland district.

During his college course, not only was Mr. DeBoest an outstanding student, but he held several prominent positions such as president of the O. S. C. Pharmaceutical association, manager of the annual drug show, president of Rho Chi, national honorary pharmaceutical fraternity; was a member of National Collegiate Players, Scabbard and Blade, honorary military fraternity, and many other equally important positions. Due to his outstanding character and ability, he was awarded the Lehn and Fink medal in 1930.

Mr. DeBoest is married to Katherine Dearborn, daughter of Dean R. H. Dearborn of the school of engineering, and has two small children.

MISS PAULINE PAUL WINS SCHOLARSHIP

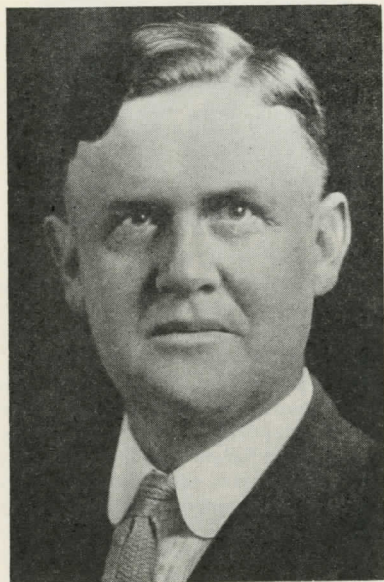

THE annual budget meeting of the State Board, a move on the part of the University of Oregon groups to have the office of chancellor abolished, the sudden appearance of a chancellor candidate in the state, and the belated issuance of outside reports on Oregon higher education, all combined to keep the system in the public eye during the past month.

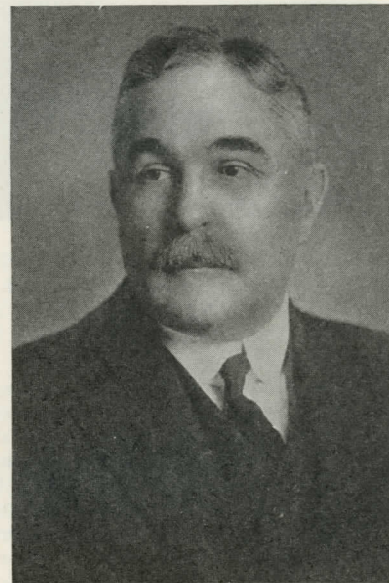
with the rules of the board were given an opportunity to present their case. Earl Wellington, president of the Dads' club, represented that organization, prefacing his remarks with the statement that his group was somewhat embarrassed by the appearance of a chancellorship candidate in the state and suggested that the board appoint a committee to meet with a commit-

Two weeks before the May 27 meeting of the board the Mothers' club of the University of Oregon passed a resolution asking for the immediate vacation of the office of chancellor, saying the university has not progressed to the satisfaction of its friends and that the presidents of the institution should report directly to the board. A similar resolution was passed by the Dads' club of the university, and both announced that committees would present the petitions at the next meeting of the board. Newspaper stories followed calling attention to the alleged extra expense entailed in maintaining the chancellor's office.

On Sunday before the Monday meeting of the board, Portland newspapers announced the arrival that day of F. M. Hunter, chancellor of the University of Denver, who had been invited by the board to view the Oregon situation and decide whether he would be interested in becoming head of the state system succeeding Dr. W. J. Kerr whose request for retirement had been in the hands of the board for more than a year. Late the previous week the Portland alumni clubs of both the university and state college issued a joint statement in opposition to the request of the Mothers' and Dads' clubs, pointing out that the chancellorship should be continued.

Delegations from both the Portland clubs were on hand at the board meeting Monday and in accordance

tee of his organization in order to compromise the matter. He declared that if the university could be given even "indefinite assurance" that science would be returned to the university and probably other concessions made, the demand for the abolition of the chancellorship would not be pressed. Asked by President Willard Marks to submit facts and figures pertinent to the situation he admitted that he had only "abstract facts" and nothing in the way of a survey to submit to the board. Following his presentation, the resolution of the Mothers' club was presented which gave very few supporting statements.

After the recess for lunch the board issued a statement disapproving the requests of the two clubs, pointing out the chancellor system provides more economical administration than was ever had before and that it is not practical to operate the unified system without a central coordinating officer. It added that if, as was stated, the University of Oregon was not making the progress desired by its friends, the reason would have to be sought apart from the administrative set-up of the board. The statement was adopted unanimously by the board and issued to the press.

The board adopted the annual budgets for the year as submitted by Chancellor Kerr. They had been made out on approximately the same level as last year, allowing each institution the total of ◀ Turn to page 12

Many Beavers Are on State Boards

Oregon State Graduates Active in Civic Functions

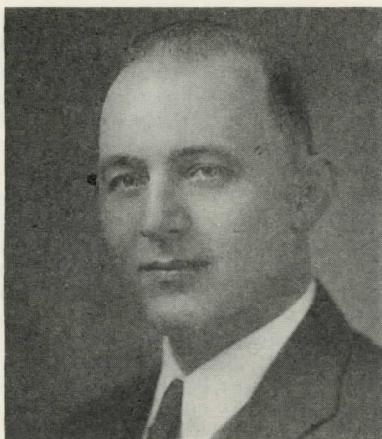

Continued from page 6 ▶ instrumental in bringing about exceptionally high requirements for entrance into their profession. And why have they done so? Because pharmacy is not merely the mixing of drugs, the compounding of physicians' prescriptions and the selling of merchandise. The pharmacist stands as a safeguard to your health and life. The pharmacist must be absolutely sure that every drug in his stock is pure; he must make frequent inspections and discard every drug substance which has deteriorated. Naturally, because of this supervision he has been one of our strongest forces in the enactment of laws governing the purity of foods and drugs. He must know the action on the body of each medicament he dispenses. Since he is directly responsible for the prescription after accepting it from a patient, he must assure himself that the amounts prescribed are the correct ones. Legally and morally he shares a responsibility as great as the physician's. It is to meet these requirements and to prevent any blot upon a cherished profession, that the pharmacists themselves have advocated and enacted laws controlling the practice of pharmacy.

A section of the Code provides that pharmacists should not sell or dispense powerful drugs or poisons to persons not properly qualified to use them. The pharmacist, being legally entrusted with the dispensing and sale of poisons, narcotics and certain alcoholic preparations, should merit the responsibility

by upholding and conforming to the laws governing the distribution of these dangerous substances.

Before making a sale of any poison a pharmacist is required by law to determine whether the poison will be used for legitimate purposes. He must be positive that the purchaser is giving his correct name and address, and he must require the purchaser to sign an official register. These precautions are taken to enable the police to detect the source of poisons in cases of murder, the poisoning of dogs and other illegitimate uses.

Other provisions of the pharmaceutical Code of Ethics are as follows: The pharmacist should consider the information he gains of the ailments of his patrons and their confidences regarding these matters as entrusted to his honor. He should never divulge such information unless required to do so by law. The pharmacist should hold the health and safety of his patrons to be of first consideration. He should make no attempt to prescribe or treat diseases. Whenever a patron requests a pharmacist to diagnose his illness and prescribe, the applicant should be referred to a licensed physician.

In cases of extreme emergency as in accidents or sudden illness on the street, pending the arrival of a physician, the pharmacist is obligated to give such aid as will prevent unnecessary suffering and death. In his college course and in his daily contacts with physicians he learns the principles of first aid. He is the most dependable first aid worker because he never administers drugs internally and above all, he knows what not do.

Choose your pharmacist with the same care with which you select your physician and your lawyer. Give him your highest confidence and your patronage.

The state of Oregon established a School of Pharmacy at Oregon State college primarily for the purpose of teaching all phases of professional pharmacy. In addition, the faculty is charged with the responsibility of eliminating all students who do not show an aptitude for pharmacy. It is gratifying to report that the state has provided excellent facilities for pharmaceutical instruction, as well as that an outstanding type of student is studying pharmacy at the College. Not only are the graduates qualified to pass a creditable examination before the State Board of Pharmacy, but for the past twenty years ◀ *Continued on page 16*

Pharmacy Cited as a Life Vocation

Dean A. Ziefle Gives Account of Drug Industry

The high school senior as he prepares to assume the responsibility of manhood faces one of life's greatest problems. The choice of a suitable vocation—one which will satisfy his ambition and still be within his limitations—requires serious study. If a high school graduate is in the upper half of his class and has a sense of responsibility, it may be assumed that he has a fair chance of being successful in college. Adaptation to a special type of work may be indicated by a natural liking for and greater success in his high school curriculum.

In addition to determining one's aptitude for a certain vocation, the most important factors to be determined are opportunities for employment and advancement in the chosen field; the success of a school in placing its graduates; income, and a number of other factors of prime importance.

Conditions would be ideal if a high school graduate could serve an apprenticeship in his chosen vocation before electing a course in college. If he is interested in law he should attend court, work in a law office, confer with attorneys and use every other means to determine whether he has an aptitude for the study of law. If he is interested in pharmacy he should work in a drug store before and after school and during holiday periods, and he should take into consideration every phase of pharmacy to determine whether he would rather devote his life to the profession of pharmacy than to any other vocation.

Since it is impossible for all prospective students to follow the appren-

ticeship system, the first two years of the pharmacy curricula are arranged so that they consist almost entirely of general academic subjects. This plan has been in operation for many years and is advantageous because a student has two years to decide on which curriculum to pursue; he is completing subjects that are acceptable for advanced credit in any standard college or university; he is making thorough preparation for the professional courses in the junior and senior years, and he is prepared to pass the examinations of state boards of pharmacy.

While it is possible to complete the first two years of the pharmacy curriculum in outside institutions and transfer to the School of Pharmacy for the last two years, at the suggestion of several students who have followed this plan it is not recommended. A pharmacy student is better prepared if he completes all of his work in one institution.

Requirements for Admission

Students who have completed the standard high school course are prepared to study pharmacy without previous experience in a drug store. The ideal high school course in preparation for the study of pharmacy, medicine and dentistry is outlined in a guidance bulletin on pharmacy published by the U. S. Department of Education which is available for distribution.

Two curricula are offered—a practical pharmacy curriculum that prepares students for the commercial phases of pharmacy, and a professional curriculum that trains students for specialization in the professional work of phar-

macy, as well as for admission to a medical school. The School of Pharmacy bulletin outlines the scope of these curricula.

Facilities for Instruction

In 1898, the pharmacists of Oregon established a department of pharmacy at the college because of the excellent facilities available for instruction in the sciences, with the supporting cultural subjects and business courses. The School of Pharmacy is housed in a separate building that is fully equipped. The school is an integral part of the College; it is state-supported and as a consequence has shared in the support of the state of Oregon and the national government.

Qualifications and Duties of a Pharmacist

A pharmacist must be cultured; he must possess professional ideals and those ethical traits that have demonstrated their importance in all of the professions; he is the custodian of drugs, poisons, narcotics and he must be trained to compound prescriptions according to the instructions from a physician. Detailed information on this subject is outlined in the college catalogue.

Pharmacy and Medical Profession

Because of the close relationship of pharmacy to medicine, the pharmacist must be trained along the same general lines as the physician. Since all standard pharmacy curricula include many of the prescribed and elective courses required for ► *Continued on page 11*

Another Class Has Joined the Alumni

Dr. Penrose, Dr. Poling Speakers at
Baccalaureate, Commencement

COMMENCEMENT at Oregon State college this year was the occasion for the presentation of 377 degrees, four of which were those of doctor of philosophy—the first ever granted by the college—36 for master of science, 10 for bachelor of arts, and 327 for bachelor of science. Those who took the Ph.D. were Herbert L. Jones and Alfred Taylor, both of Corvallis; Karl Klem, of Berkeley, Calif., and Clarence Burnham of Brigham, Utah. No honorary degrees were conferred.

Dr. Stephen B. L. Penrose, president emeritus of Whitman college, delivered the baccalaureate sermon using "Courage" as his topic, and Dr. Daniel A. Poling, author and lecturer of New York, was the commencement speaker, with "Have Faith in America" as his subject.

"To have courage of one's convictions is essential to the progressive person of today," Dr. Penrose told the seniors. "This conviction may make you unhappy and not win the approval of the mob, but it is a necessary characteristic.

"America is cunning and clever, but not courageous," he continued, naming Jesus as the "most courageous man in all human history." Dr. Penrose condemned radicals generally but added that "few are radical for righteousness."

Dr. Poling stressed education as a basic and permanent cure for unemployment in his commencement address. "Education is a cure that comprehends not merely a symptom of a national disease, but that goes to the very root of industrial, of social, of cultural and of moral causes."

He asked for one billion of the huge federal public works program funds and showed the possibility of eliminating unemployment by keeping the youth of the country in school. This would not only limit the number not gainfully employed but would raise the level of culture among our people, he said. It would enrich all human relationships. It would provide for home and school, for church and state, new and richer flow of trained leaders. It would sweep away barricades of intolerance and would make America strong, he said.

In defending the modern system of government of this country, Dr. Poling stated it was the best yet devised by man, and reproached those who would tear it down.

"It is this same system that today protects the very men and women who ignore its past, belittle its present and renounce its future. The way out is the way ahead. The way of individual liberty joined to social service and participation in government. The way out is the American way," he concluded.

Dr. W. J. Kerr, chancellor of higher education in Oregon, was on the campus to officiate at the graduation of the 1935 class and took his place at the head of

the academic procession beside B. F. Irvine, editor of the Oregon Journal and a member of the state board of higher education. Both men played important parts in the affairs of the weekend.

Continued from page 8 ▶ its former budget with slight necessary additions to cover the restoration of 10 per cent of the salary cuts and enough to cover increased cost of supplies. The combined budgets were therefore approximately \$23,000 higher than the year previously, constituting a one percent increase. Total estimated income for the year for unrestricted use was given as \$2,398,057 while the estimated requirements totaled \$2,454,169.29. An estimated balance on June 1 of \$116,000 permitted the board to balance its budget and carry over a surplus of approximately \$60,000 to meet unforeseen contingencies.

Much of the remainder of the meeting was devoted to matters in connection with PWA building programs throughout the system. Final financial arrangements were made for the handling of the state college infirmary financing without endangering either the payments on the Memorial Union building or the remaining obligations of the Associated Students for the stadium construction.

Adoption of the budgets also carried with it approval of various personnel adjustments throughout the institutions, many of which were more or less of a routine nature coming at the conclusion of any year. The state college was authorized to add enough instructors to care for the continuation of increased enrollment, particularly in the school of forestry. Only one actual new appointment was confirmed, that of Harry A. Fowells, '32, who will be instructor in forestry. Authorization was given to appoint a director of women's physical education but the selection had not been made. R. H. Dearborn, acting dean of engineering, was advanced to the full rank of dean and S. H. Graf, '07, acting head of mechanical engineering, was made head of that department. Alfred Taylor, one of the first four men to receive a Ph.D. degree from the college, was advanced from graduate assistant to instructor in zoology. F. E. Price, '22, was continued as acting head of the department of agricultural engineering in the absence of W. J. Gilmore.

Every member of the board with the exception of F. E. Callister was present at the meeting. It was the first session attended by Edward C. Pease of The Dalles since his appointment by Governor Charles H. Martin to succeed Mrs. Cornelia ◀ *Turn to page 15*

Summary of Oregon State Athletics Given

Art Taaffe Works Pencil Overtime in Doping Out Percentages

OREGON State athletes, both varsity and freshman, batted exactly .531 for all contests in all sports for the college year just closed. The rooks did somewhat better than the varsity, winning 25 contests and losing 15 for a percentage of .625. The varsity won 43 contests and lost 45 for a percentage of .489.

Basketball, under the coaching of Slat Gill, enjoyed the most successful season of all when the Orange cagemen captured the northern division championship for the second time in three years and lost to Southern California, southern division champion, by one point in the playoff series here.

Baseball, also under the guidance of Coach Gill, came next in success among the varsity sports. The Orangemen finished in a tie with Washington State college for third place with eight wins and eight losses.

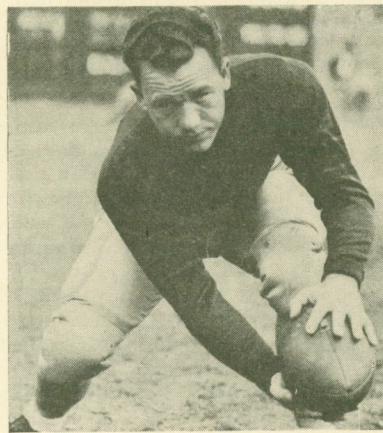
Grant Swan, varsity track coach, was severely handicapped the past season due mostly to the lack of outstanding material. The Orange cindermen won only one conference meet and that from University of Idaho.

Football, the fourth of the major sports, got off to a poor start when Norman Franklin, the chief ball carrier who was chosen all-American in 1933, was injured in an early season non-conference game. Franklin never entirely recovered and as Lon Stiner, head coach, had no man of outstanding ability to take Franklin's place the Orange attack suffered as a result.

Freshmen fared well in all sports with the exception of basketball in which they lost three of the four games with University of Oregon frosh.

Crew, which has been making rapid strides here in recent years, was recognized as a special sport by the associated students this year. The sport has been conducted strictly as a class activity in the past.

With some outstanding material coming up from this year's freshman class in all sports and several good holdovers from the varsity, prospects in the field of sports here for next year are more than promising. The addition of Laurie Walquist to the football coaching staff should bolster this department considerably. Walquist, former University of Illinois quarterback, came to Oregon State directly from the Chicago Bears, national professional football team.

Continued from page 10 ► admission to a medical school, every pharmacy student is also a premedical student. Since an increasing number of graduates in pharmacy are studying medicine, curricula in pharmacy are arranged to meet premedical requirements. Since the establishment of pharmaceutical instruction at the college in 1898, over one hundred pharmacy students have been admitted to a medical school and many are outstanding practicing physicians.

Opportunities for Graduate Pharmacists

In order to become familiar with the practical phases of pharmacy about 90 per cent of the alumni engage in practical drug store work immediately after graduation. After gaining several years of experience they either continue as registered pharmacists and proprietors of drug stores, or in the professional phases of pharmacy. More detailed information may be found on this subject in the School of Pharmacy bulletin.

No field of work offers more desirable opportunities for women than pharmacy. Since women purchase over seventy per cent of the drugs and druggists' sundries sold, naturally they prefer to deal with women pharmacists.

While the salaries of registered phar-

macists differ in different sections of the country, a good estimate is from \$20.00 to \$30.00 a week, increasing in proportion to the pharmacists' ability to take over responsibility. The chief concern of the graduate of any college curriculum under present economic conditions should be whether there is reasonable opportunity for employment even at a living wage.

The annual directory of alumni published in this issue of the Oregon State Monthly shows that a surprisingly large number of the graduates of the School of Pharmacy have secured good positions. Almost without exception there is an Oregon State graduate in pharmacy in every city and town in the state of Oregon. All such graduates are rendering an outstanding professional service in their respective communities. The same opportunities are available to high school graduates who are dependable and interested in public health work.

Continued from page 12. Marvin Pierce. A somewhat heated discourse between the governor in Oregon and Mrs. Pierce in Washington, D. C., over the attendance of board meetings resulted in Mr. Pease being named as her successor. He previously was a member of this body.

The state board, its committees and Chancellor Kerr held a number of conferences with Dr. Hunter and arranged for him to visit three of the campuses before his return to Denver. He was taken from Portland to Corvallis by President Peavy, stopping en route to visit the Oregon Normal school at Monmouth, later taking lunch with the administrative council on the college campus. From there he went to the University of Oregon, returning to Portland that evening and departing at once for Denver.

Two days following the adjournment of the state board meeting the Oregon papers carried stories under a Washington, D. C., date line announcing publication of the report of the special committee of the American Association of University Professors dealing with the Oregon situation. A committee of three members of the A. A. U. P. had been in the state late in 1933 following the Morse-Nelson episode and came to the state following complaints made to the national board by the University of Oregon chapter. No report had ever been made public between that time and this. The Oregon State College chapter of the A. A. U. P. had been informed that a report was pending, and used its influence in an attempt to convince the national board that only harm could come from publication at this late date. The newspaper release of the report was accomplished before the printed copies of the journal of the society containing it had been received in the state. On inquiry it was found that the University of Oregon chapter of the A. A. U. P. had made mimeographed copies of advance proof and supplied these to newspaper offices and press associations. These were accompanied by a letter of transmittal and signed

and located in Portland, with those on the College campus. A lack of such unification has in the past been at times a handicap, and has occasionally led to misunderstandings. We are not organized to supersede or take over any activity for which any of these groups are responsible.

"While this group was organized only last November, three things have already been accomplished, which amply justify its existence. We have been instrumental in reviving the Portland Alumni Club. Through the Associated Clubs, with the work largely done by A. E. Finlay, the College band was brought to Portland three weeks ago, gave a free Sunday afternoon concert in the Benson Auditorium, and while there, made a record of the Oregon State Medley, which is now for sale for the first time, and available through the Alumni office on the campus. The third thing they have done is, in my estimation, the most important of all,

by Wayne L. Morse, president, and Harold J. Noble, secretary, of the U. of O. chapter.

The report contained a complete re-hash of charges against the administration of Chancellor Kerr which had been laid before the committee by the University of Oregon chapter. While these charges were all restated they were rarely accompanied by findings of fact. The state board was criticized by the committee for having elected Chancellor Kerr in the first place and for having failed to obtain a successor since his request for retirement.

The appearance of the report was greeted by a storm of protest throughout the state. The daily press outside of Eugene denounced it as untimely and unwise and many criticized severely both the committee which made the report and those who had evidently been encouraging its publication. President Marks issued a statement declaring that the board refuses to be stampeded into the selection of a chancellor by this or any other committee. Because of the repetition in the report of charges impugning his personal integrity, Chancellor Kerr issued a statement which was widely published. Many of the editors of the state commenting on the situation denounced most vigorously all who had any connection with the attack on the chancellor and the board. The state college forces took no part in the controversy except for the adoption of a resolution by the Alumni association as mentioned elsewhere in this issue.

and is the work which made possible the joint statement to the press on behalf of the Portland Alumni of the University of Oregon and the Portland Alumni of Oregon State College when the disturbance was raised relative to the Chancellor system some two weeks ago.

"As a group we are interested in the same things in which the Alumni and friends of the College generally are interested. We believe in the State System of Higher Education, and in the Board of Higher Education which is directing that system. We believe in the College and the field that it occupies under the direction of the Board. We are interested in those things that will build for a better state. We are decidedly not interested in carping criticism, and petty jealousies. We are not interested in formenting dissension. As I said a moment ago, we believe in our college and in our state, and will work toward preserving the ideals for

which they stand. We believe in the land grant college and in the value of the field graduates thereof are prepared to occupy. We believe in the dignity of agriculture and farming; for forestry and lumbering; of engineering; the sciences; and home economics, and in the homes made richer by the training available here to young women. In other words, we are sold on our school. The highest compliment that I can pay it is that I know of no place I would rather send my own son, both for the training available here and for the social and moral influences that prevail.

"We believe in those who are the constituted authorities in this nation, our state, and our educational system. We do not believe in anti-governmental propaganda, call it by any name you will. We have no place here for those who by one name or another would wreck the nation, our state, our schools, and our homes. They oppose the things for which this school stands—call them

communists, liberals, or by some other name. The communist party vigorously opposes the Reserve Officers Training Corps. One of the organizations of young communists has as its slogan, "Crush the Boy Scouts". The communist presidential platform for 1928 called for abolishing the Supreme Court, abolishing the United States Senate, and abolishing the veto power of the president. It also called for removal of all barriers to inter-racial marriage, and demanded the right to vote of all foreign born and migratory workers. These are absolutely contrary to the spirit of the land grant college.

"We honor the men and women who have given their lives in the building of this institution, and we do so without regard for the size or number of college or university degrees. Men are not judged by the degrees written after their names, but by the monuments built through their life work.

"The story is told of President Coolidge that during the time he was in the White House, a series of critical biographies of George Washington made their appearance. A friend who was calling on Mr. Coolidge asked him what he thought of them. Mr. Coolidge did not reply, but rose from his desk, went to the White House windows, pulled aside the curtain, and looked across the grounds to where that towering shaft of marble known as the Washington Monument stands. Mr. Coolidge gazed at it a few moments, and turned around with the remark, "Well, I see the monument is still there." Yes, it still stands, and so does this one. Not only this building, but this school, and to the preservation of this monument and the things for which it stands we of the Associated Clubs pledge our support and ask the enthusiastic help of all alumni and friends of this school in carrying out that hope and aim."

In addition to the offices of the association, the Institute will contain a reference library, a historical museum illustrating the development of pharmacy in this country and a research laboratory devoted to the discovery and improvement of standards for the identity, purity and strength of drugs and medicines.

Later on it is expected that other associations devoted to professional and scientific pharmacy will occupy space in the Institute and that it will become the home of American pharmacy.

Dr. Robert P. Fischelis, president of the American Pharmaceutical Association, is the first president to be installed in the new building. He is an outstanding man in the field of pharmacy as may be judged from the long list of his activities.

Graduates of a standard four-year curriculum in pharmacy are trained to accept positions demanding more knowledge of the sciences than is required to compound prescriptions and to perform other professional service in a drug store. Although it is recommended that every graduate gain two or three years experience in a drug store, he is expected to strive for a higher position such as are now held by the majority of graduates of the school of pharmacy.

Directory of O.S.C. Pharmacy Grads

Compiled by Miss Myrtle Burnap, Secretary

THE annual directory of the school of pharmacy reveals that 75 per cent of the graduates of the Oregon State school of pharmacy are doing work directly or closely associated with their training.

In the 37 years since the organization of the school, 669 students have been graduated, of which 555 are men and 114 women. Since graduation was not required by the Oregon state board of pharmacy until 1925, hundreds of students prepared for pharmacy practice at the college without this qualification. All pharmacy graduates must pass a state pharmacy examination before being eligible to practice.

A registered pharmacist in Oregon may practice without further examination in all other states except California and New York which do not reciprocate with any state. Oregon State students have never experienced difficulty in passing the examinations in either of these states.

Because of the fact that there are changes in the directory almost every week, it is impossible to give accurate percentages, however, according to the latest information, the following shows the vocations of the graduates with percentages:

Registered pharmacists and managers of drug stores, 32.44 per cent; proprietors, 26 per cent; miscellaneous (including chemists, medical students, general merchants, et cetera) 15.35 per cent; instructors in colleges and universities, 2.57 per cent; traveling representatives for drug manufacturing firms, 4.96 per cent; practicing physicians, 6.57 per cent; housewives, 8.08 per cent; and deceased, 4.03 per cent.

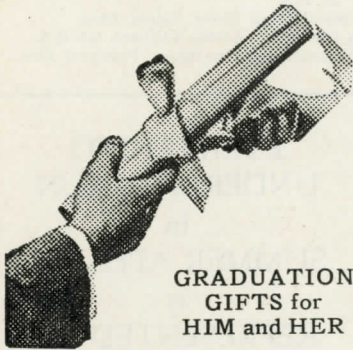
